



Update: Notice of works at Newyears Green Lane

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

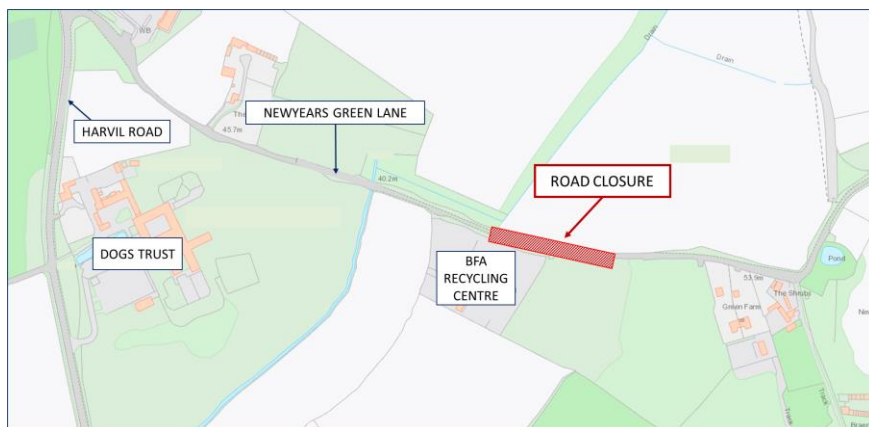

What we are doing

We wrote to you in May to advise you that we would be carrying out ecological surveys on 17 May and 1 June along Newyears Green Lane in the area shown on the map below.

Due to poor weather conditions, we were unable to complete the surveys. We therefore require additional time to complete these works which will now be completed on 1 and 14 June 2021.

A road closure will be required between 8pm and 5am to ensure these works can be carried out safely.
