Sewer pipeline installation works on Hampstead Road

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites remain under constant review. You can sign up for regular updates in your local area at HS2inCamden.co.uk.

From 12 July until the end of August sewer pipeline installation works will continue across Hampstead Road (near to Lindale) in two phases:

Phase 1: 12 July to 31 July 2021 (3 weeks) – Sewer pipeline installation in northbound lanes and one southbound lane.

Phase 2: 2 August to 21 August 2021 (3 weeks) – Sewer pipeline installation in remaining southbound lanes connecting to existing sewer.

During both phases the junction to Varndell Street from Hampstead Road will be closed. Access to Varndell Street will be via Robert Street and Stanhope Street.

The initial digging of the road will be the noisiest activity, although this will be intermittent and not continuous. We will put up screening clad with acoustic panels to reduce noise.

We might use a vacuum excavator, which is a safer and faster way of working, as it sucks up material to expose buried utility services without risk of damaging the cables or pipework below. This is a noisier method, and we erect acoustic barriers around the machine, however a lot of the noise would be sent vertically, when the machine is running.

Utility supplies and other services will not be affected by these works.

The southbound bus lane and bus stop W will be temporarily suspended. The nearest alternative bus stops are Robert Street stop J and bus stop K near the corner of Netley Street and at Mornington Crescent underground station. We apologise in advance for inconvenience this might cause.

This work is coordinated with SCS, HS2 Main Works contractor, who are currently carrying out Hampstead Road central reserve removal works until end August, please see a map on the next page for further details.

What to expect:

Varndell Street junction with Hampstead Road closure for duration of works

Diversion route via Robert Street and Stanhope Street

Traffic management around work sites and in surrounding roads.

Two-way traffic lights on Hampstead Road.

Pedestrian access will be maintained during the works.

Southbound bus lane and bus stop W suspension.

Ongoing removal of Hampstead Road central reserve by SCS until end August

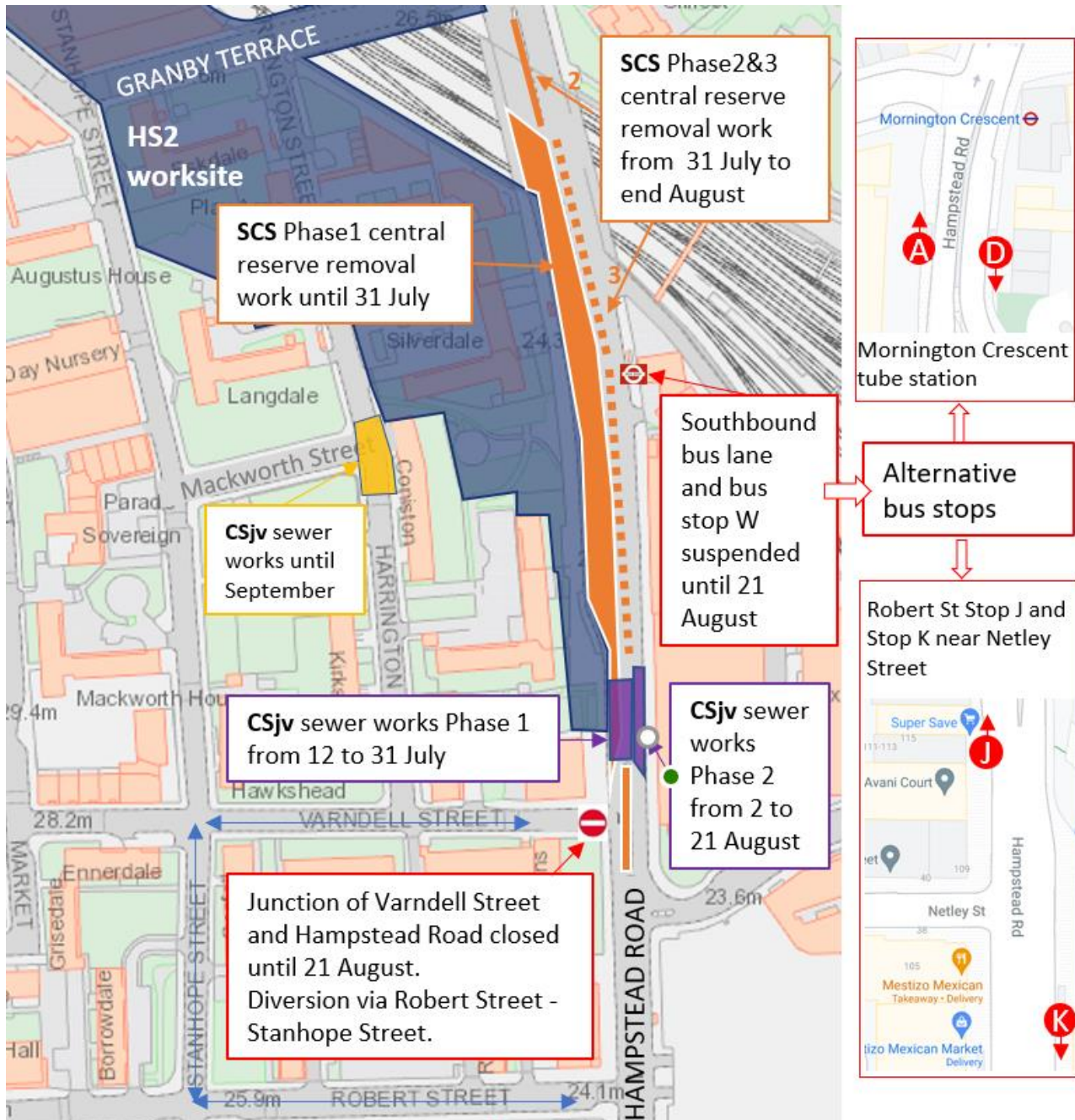
