

Update: Works on North Gower Street and Drummond Street

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites remain under constant review. You can sign up for regular updates in your local area at www.HS2inCamden.co.uk.

From 24 May until 6 August 2021 utilities works for electrical power connections will take place in the road of Drummond Street and North Gower Street. Excavation and ducting work will be carried out in phases, please see the phasing below and a map on the next page;

Phase 1: **Complete**

Phase 2: **Complete**

Phase 3: **26 June to 12 July 2021 (two weeks) – Works now need to extend into Drummond Street but vehicle access will remain. This phase of works will need a full road closure at North Gower Street junction with Drummond Street. 'PLEASE FIND ALTERNATIVE ROUTE' signage will be in place. The reason for this closure is because the cabling now needs to be laid at deeper depth due to other utilities in the area. The initial digging of the road will be the noisiest activity, although this will be intermittent and not continuous. We will put up screening clad with acoustic panels to reduce noise where applicable.**

Duct cleaning and CCTV: **12 July to 19 July 2021 (one week)** – Ensuring and proving that ducts are clear of obstacles, ready for cables to be pulled through at a later date. These works are non-intrusive which will minimise any disruption to the area.

Reinstatement: **19 July to 6 August (three weeks)**

Utility supplies and other services will not be affected by these works.

What to expect:

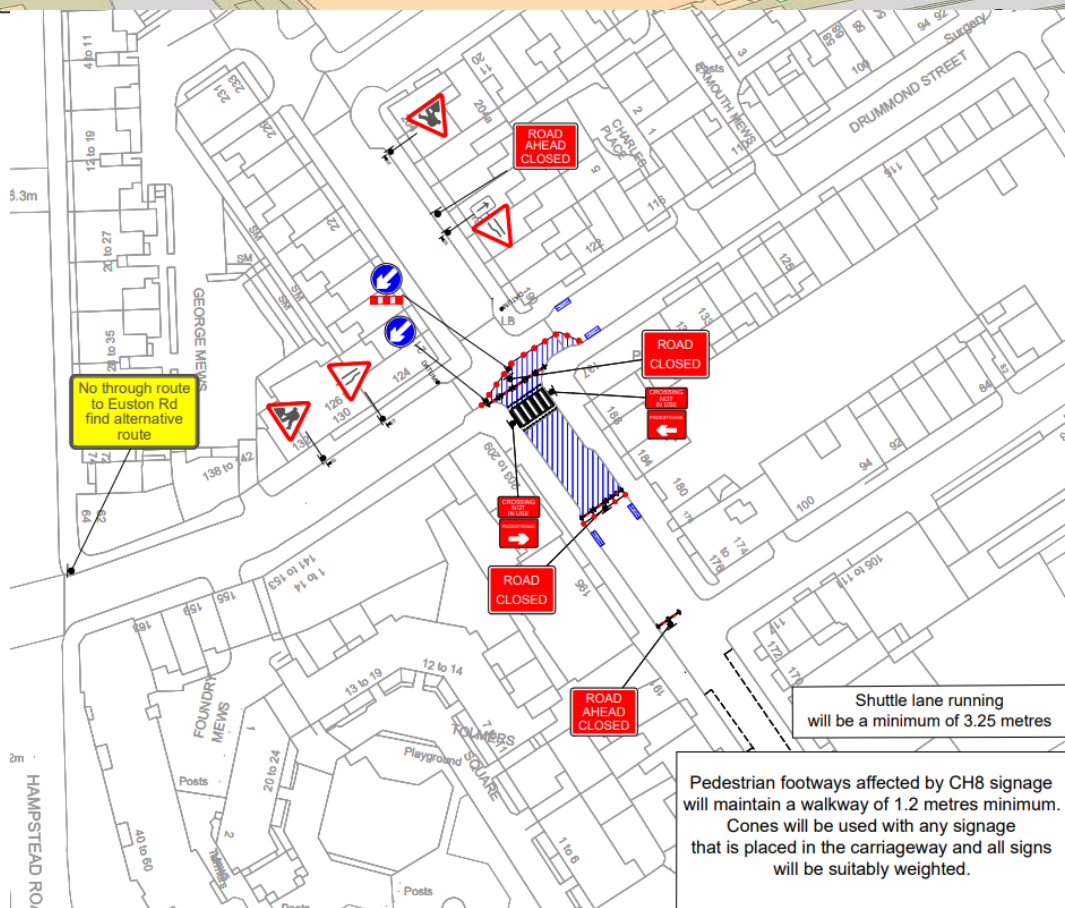
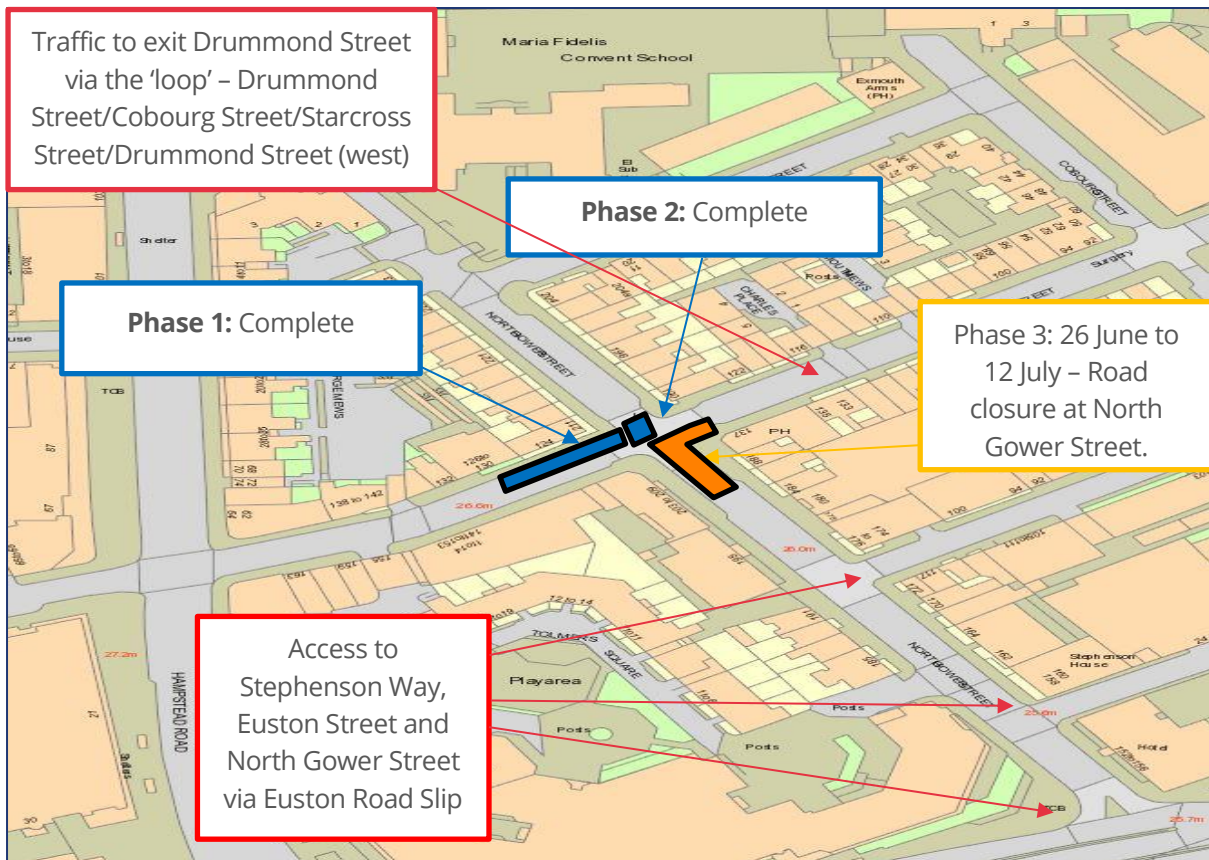
Traffic to exit Drummond Street via the 'loop' – Drummond Street / Cobourg Street / Starcross Street / Drummond Street (west).
