# Update: utility works on Parkway and Park Village East

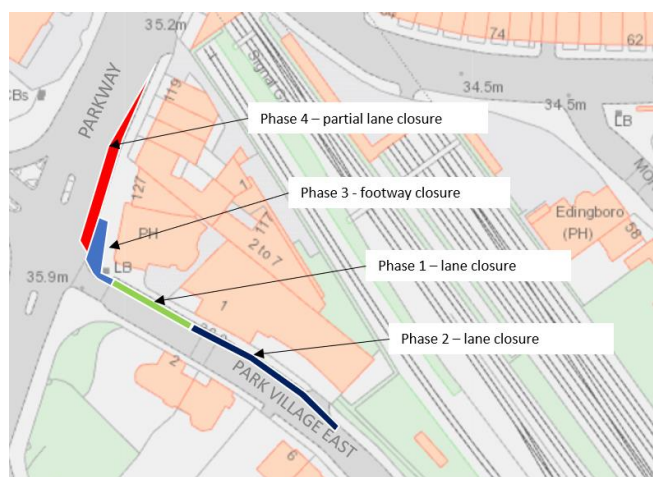
High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. ## UKPN cable install on Parkway and Park Village East – extended until 16 July

UKPN is currently installing high power electricity cables within the footway and carriageway on Parkway and Park Village East. Due to unforeseen delays, these works have now been extended until 16 July.

UKPN is currently completing phase 1 and 2 of the works on Park Village East. From 7 July, UKPN will install cables within the footway on the corner of Park Village East and Parkway (phase 3 on the map), before carrying out the final phase of work within the carriageway on Parkway (phase 4).
