

Upcoming utility works on Parkway

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. Please be assured only sites that can operate within the guidelines are operational. You can sign up for regular updates in your local area at HS2inCamden.co.uk.

Overnight CCTV survey on Parkway – 12 to 13 July

From 8pm on 12 July to 5am on 13 July we will carry out a CCTV survey of the Thames Water main on Parkway.

This work will not be noisy and should not cause any water disruption, it will be carried out overnight to limit impact on local traffic. We will access the utilities via existing manholes within the road and use a camera to assess the condition of the water main. We will close a section of the lane in front of North Bridge House Prep School to create a safe working area.

This survey will be used to inform the final design of the Parkway utility diversion works. We will begin works to strengthen and divert the utilities beneath Parkway in January 2022, before we begin tunnelling, to prevent potential damage to the utilities from tunnel-related ground movement.
