



# Notice of works on Curzon Street site gate

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

## Changes to site gate

As we prepare to construct the new railway, we will need to remove an existing gate from the Curzon Street site and install a new site access gate for our compound. We will be carrying out this work on Monday 28 June and expect to complete the work within one day.

## Temporary traffic lights

To be able to complete this work safely we will need to put in place temporary traffic lights on Curzon Street and Cardigan Street. The lights will be operational from 9.30am – 3.30pm.

## HS2 during the COVID-19 pandemic

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with guidance. 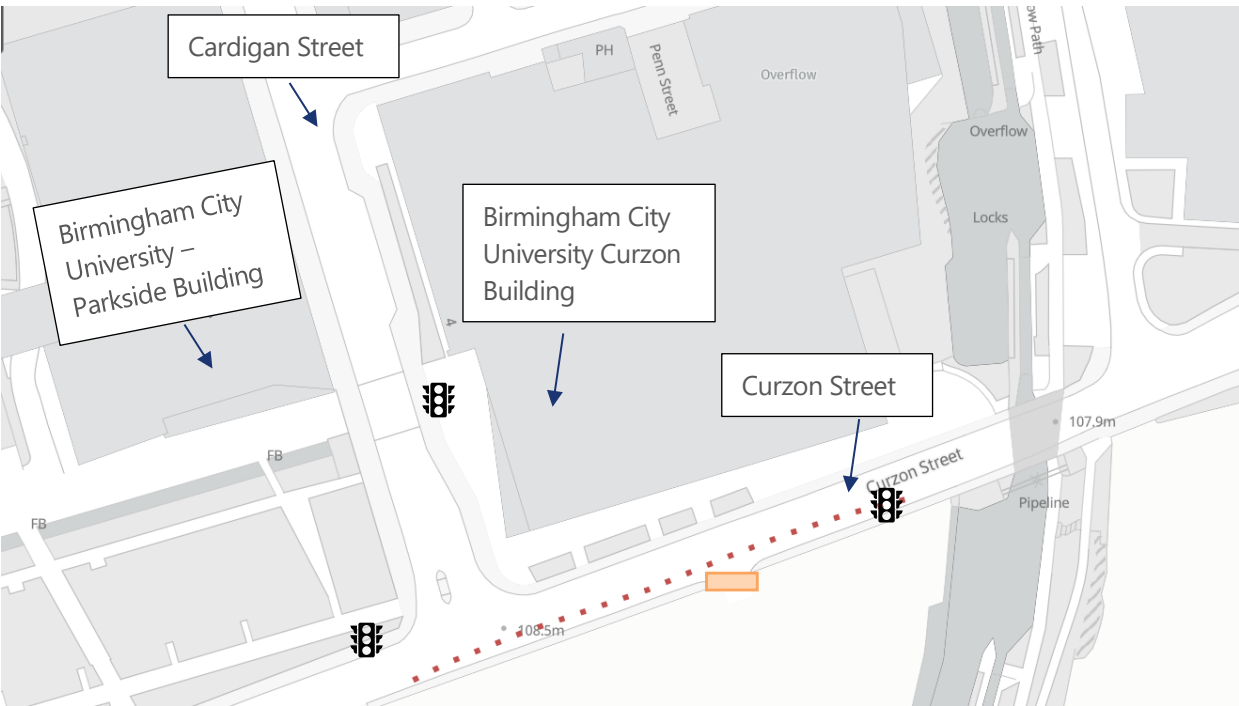
