High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with Covid-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance.

Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. We have postponed all face-to-face engagement events and meetings and have put in place several channels to communicate with communities, such as letters, phone calls and webinars as well as updates and alerts from each of the local community websites. What works are taking place?

HS2 contractors Align JV will be carrying out monitoring and maintenance works on the M25 on both the clockwise and anticlockwise emergency lane/hard shoulder between Junction 16 (Denham Interchange) and Junction 17 (Maple Cross Interchange).

The maintenance work will be carried out across four days on three separate occasions (once a month) during the daytime. Works will take place mid-June, mid-July, and mid-August 2021. Details of the phasing, dates and carriageways affected are listed in the table overleaf. There will be emergency lane/hard shoulder closures in place on both carriageways from 9:30am to 4pm each day whilst the maintenance takes place.

Advance warning signage will be put in place prior to the works taking place. Whilst disruption will be kept to a minimum, we would remind road users to plan their journeys and to be aware of the temporary emergency lane/hard shoulder closures to allow the works to be carried out safely.
