Update: Notice of works in Rabournmead Drive area

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

What we are doing

We wrote to you previously to advise you that we would be carrying out works from 4 to 18 May 2021. However, we will require additional time to complete these works and the works will now take place from 14 to 19 June 2021.

We will be clearing vegetation to assist with further ground investigations. We will remove bramble vegetation using hand tools, in the area shown in the map below.

From 14 to 19 June 2021 8am to 6pm Monday to Friday and 8am to 1 pm on Saturday
