High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by a joint venture between Laing O'Rourke and Murphy & Sons known as LM.

Utility works on New Canal Street

Over the coming months, we'll continue to work on roads in central Birmingham as we carry out a programme of utility diversions and prepare for the construction of HS2's Curzon Street Station and the railway. This includes phased lane closures of New Canal Street w/c Monday 21 June for approximately 5 days.
