

# Notice of M40 J11 new traffic signal installation

High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. ## What are we doing?

We are writing to update you on the night-time slip road lane closures required on the M40 Junction 11. This will take place over the period 21 June to 17 July 2021, between the hours of 8pm to 6am.

We will be closing lanes on the northbound and southbound exit slip roads on the M40 at Junction 11. The lane closures are to enable completion works for the new traffic signals to the motorway slip lanes and 'A' road approaches. We will also be installing traffic detection surface loops which control traffic volume on the roundabout, and traffic monitoring cameras.

There will be no full slip road closures for this phase of works.

## How will this affect me?

You may need to allow more time when you plan your journey. The lane closures will be clearly sign posted with advance warning signs.

The works will be carried out over nightshifts from 21 June to 17 July 2021

Night-time lane closures on the M40 Junction 11 slip roads with traffic management in place between the hours of 8pm to 6am.

Some additional traffic on local roads. Some noise from equipment used for the works.
