# HS2

## Notice of temporary closures on Stoneleigh Road and Stareton Lane

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

As part of LM's work near Stoneleigh, there will be road closures in two phases on Stoneleigh Road and Stareton Lane from **Monday 28 June including weekends**, subject to consent:

- **Phase one:** closure on Stoneleigh Road, north of Stoneleigh Park's main entrance, **28 June to 4 July 2021**
- **Phase two:** closure on Stoneleigh Road and Stareton Lane, south of Stoneleigh Park entrance, **5 July to 11 July 2021**

Diversions will be in place between **9:30am and 3:30pm** including weekends. Our teams may be on site up to one hour before and one hour after work to set up or pack up.

We will also be undertaking similar work on Dalehouse Lane, Leicester Lane and Coventry Road in Summer 2021.

Maps on the following pages show the diversion routes, which will also be signed on local roads. Access to properties and businesses will be marshalled and maintained, including Stoneleigh Park, local vaccination centres and Abbey Park.

### Working closely with the NHS

The NHS is operating a vaccination centre at Stoneleigh Park. Please be assured that HS2 and our contractors are working closely with the NHS throughout the planning of all our work in the area, helping to ensure that we do not affect the successful operation of the centre.

### HS2 and the COVID-19 pandemic

The Government's current COVID-19 strategy makes it clear that construction activity can continue if it complies with Government and Public Health England (PHE) advice on dealing with COVID-19.

The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

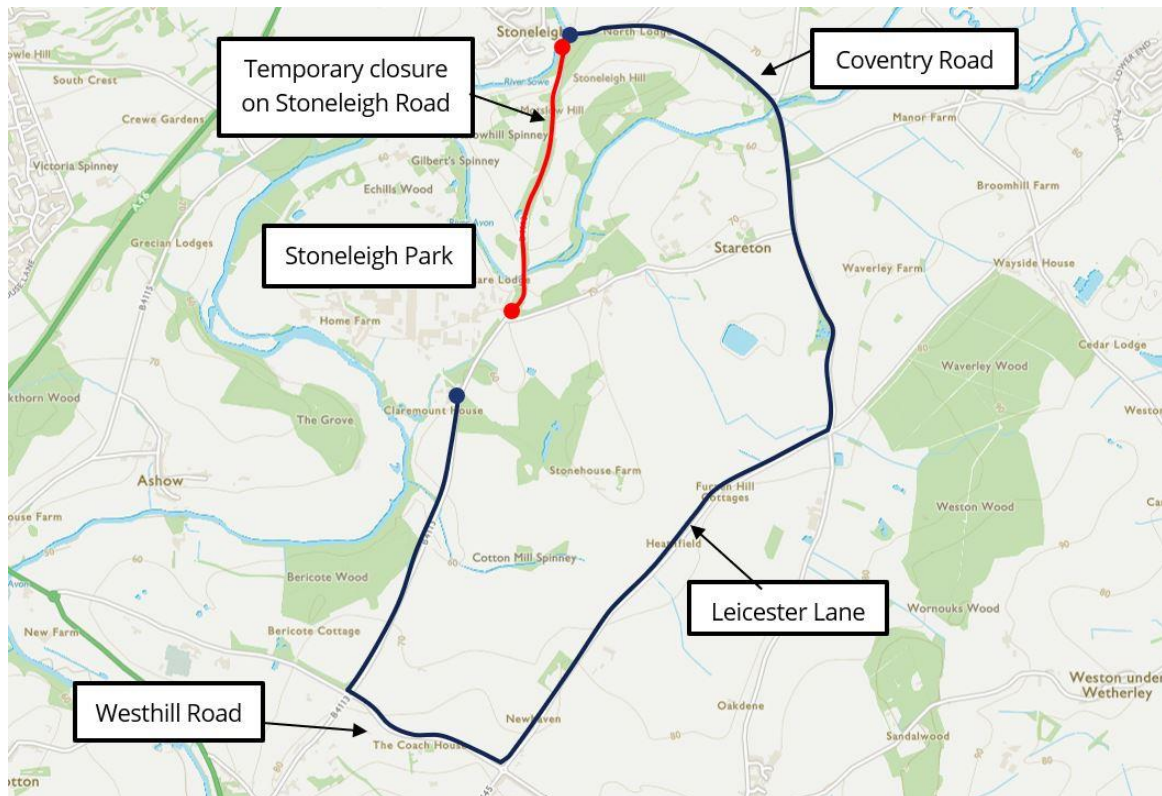
### What we will do

Keep all sites safe and secure, while keeping disruption to a minimum.

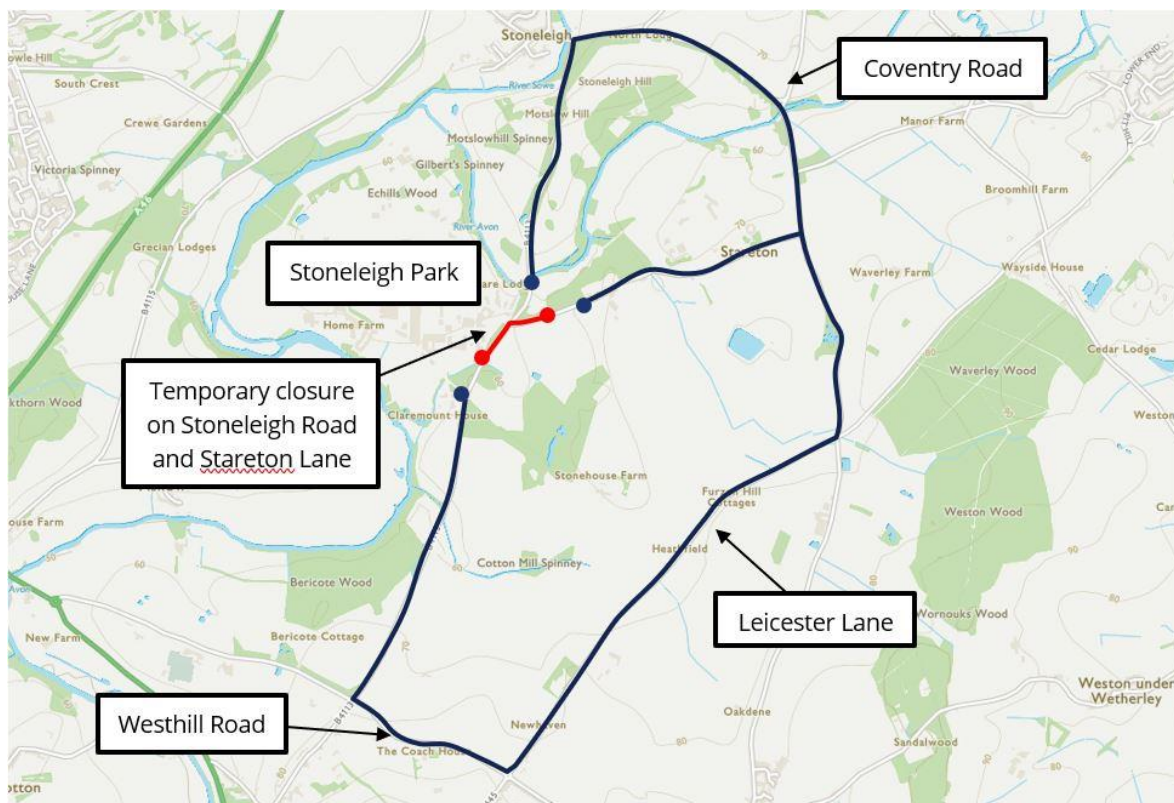
Ensure all traffic management is clearly signed.
