Notice of culvert surveys at Breakspear Road South and Harvil Road

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

What we are doing

From 12 to 30 July 2021, we will be carrying out overnight surveys along Breakspear Road South and Harvil Road, in the area shown on the map overleaf. This will help to inform our design decisions in the area.

We will capture 3-dimensional information on the drainage ditches and culverts in the area using a CCTV camera mounted on a small robot. Should we find a blockage, we may need to flush the drainage system using a high-pressure water jet to carry out the investigation.

These surveys are taking place between 8pm and 5am to minimise impacts on the local road network. Temporary traffic management will be in place to ensure the surveys can be carried out safely and will be removed at the end of each shift.

Your utility services will not be affected.

- Harvil Road from 26 to 30 July

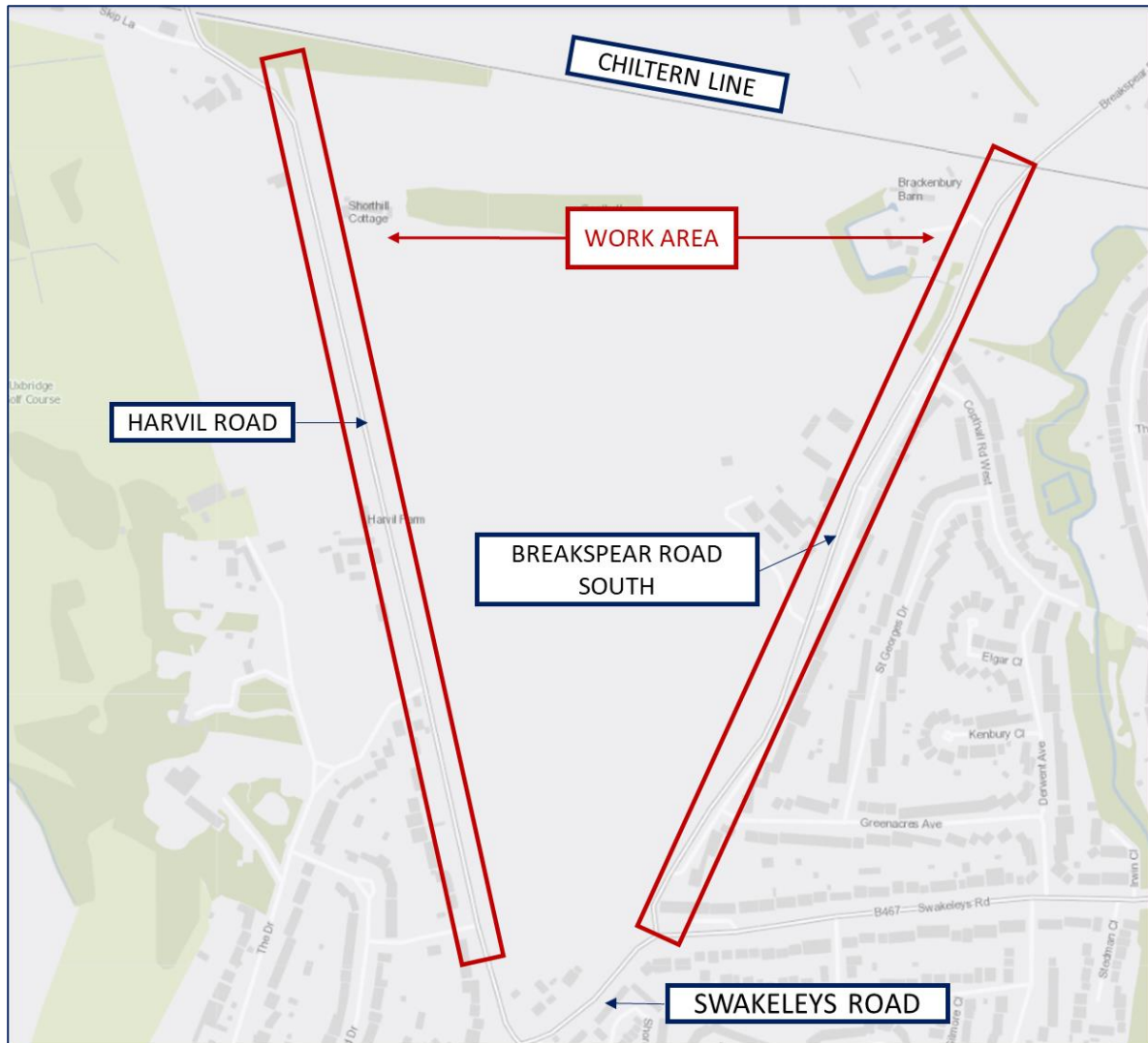
