## Notification



High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

### Surveyor visits

From 12 to 17 July 2021, our surveying team will be visiting railway bridges on Oldfield Lane, Long Drive, Bridgewater Road and West End Road to carry out surveys. More information about the survey locations is included on the next page. The surveys will help to inform our design decisions in the area.

We will take pictures and investigate the condition of the bridges using a mobile tower and ladders. These surveys should not cause any disruption.

Due to the location of the surveys, temporary traffic management will be in place to ensure the activity can be carried out safely.

- West End Road 12 to 14 July

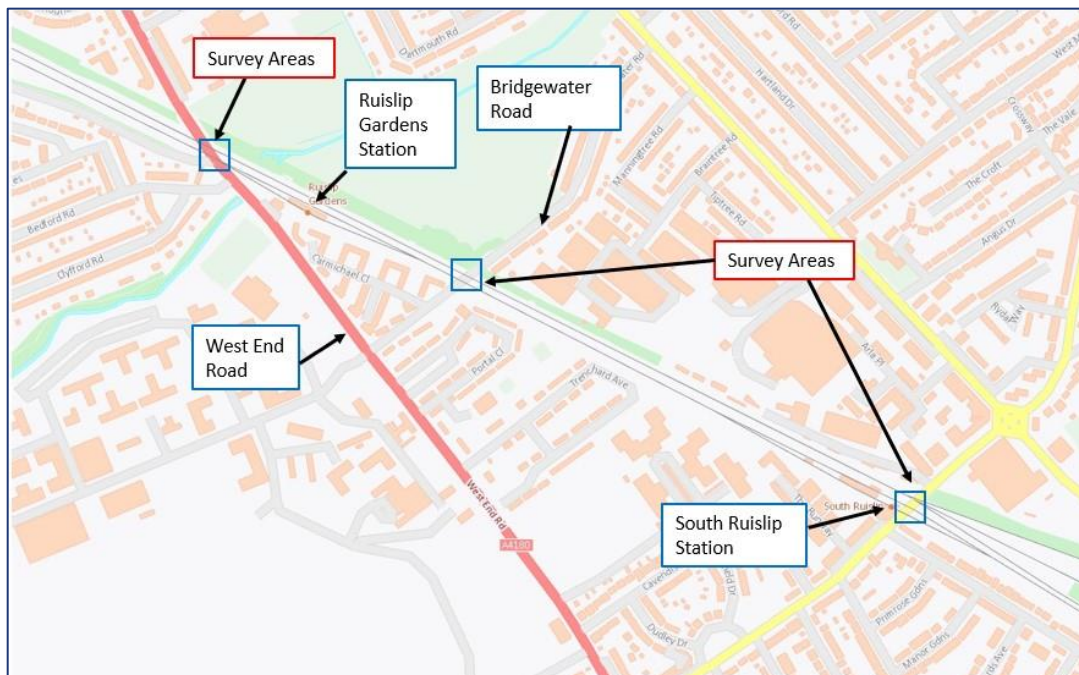
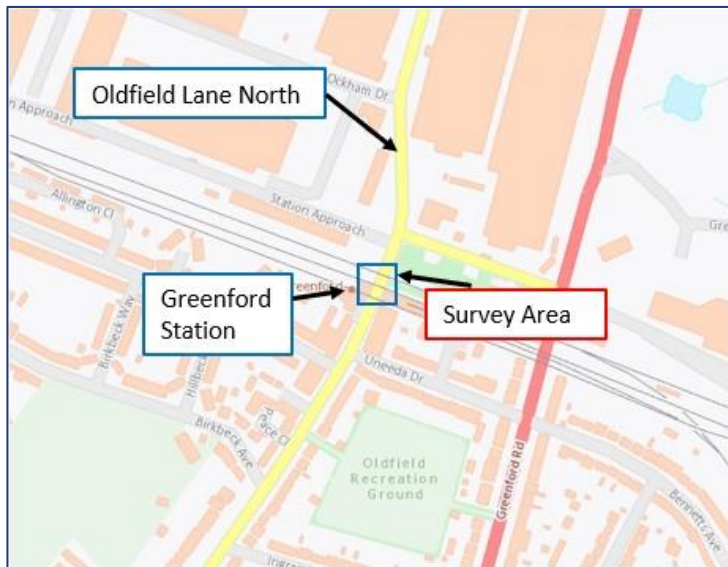
