



## Notice of temporary traffic lights: B4115 Ashow Road

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

### The work we will be doing

We need to have temporary traffic lights in place on the B4115, Ashow Road between Stoneleigh and Crewe Lane. This is to allow us to construct a new site compound. At busy periods the traffic lights will be manually operated to speed up journey times. There are no road closures due to take place.

We thank you for your patience as we complete this vital work.

### When these works will take place

Works will take place between **28 June and 2 July** where temporary traffic lights will be in place for five days.

### HS2 during the Coronavirus pandemic

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with coronavirus.

The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance.

The health and safety of our workforce and the communities we affect is our key priority.

Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

### Duration of works

Works are scheduled to start 28 June – 2 July 2021.

Traffic lights will operate 24 hours per day with manually operated lights at busy periods to speed up journeys.

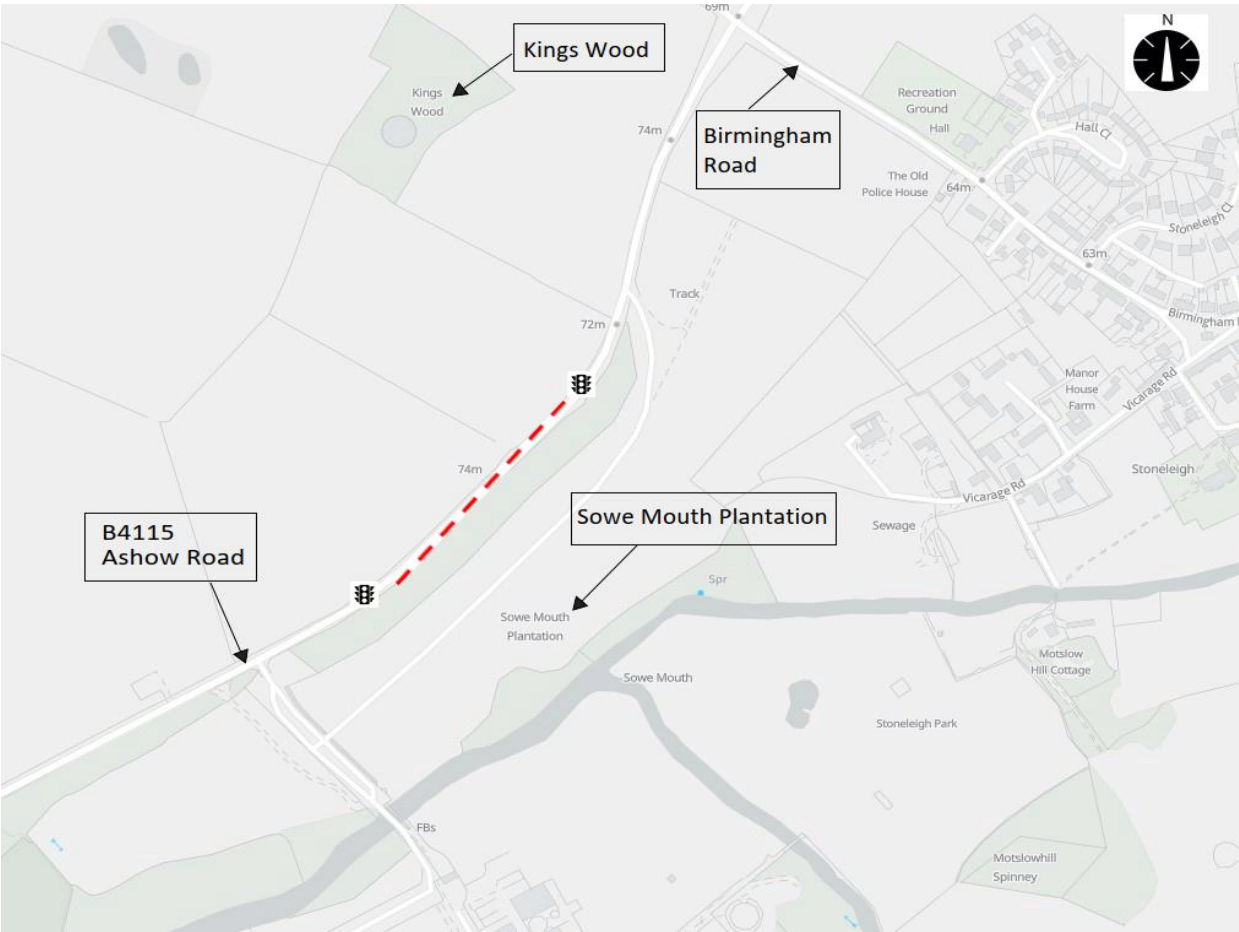
