High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

Upcoming utility surveys

We will be carrying out utility trial hole surveys in locations along Aston Church Road on Monday 12 July and Tuesday 13 July, dates are subject to the progress of the surveys programme.

To complete the utility trial hole inspections, we will use a vacuum excavator, which uses compressed air to loosen or agitate the ground. The loosened material is then removed using the vacuum on the machine creating a hole. At times we will also use hand digging tools to excavate the trial holes. Once the surveys are carried out, we will backfill and reinstate all the trial holes.

These surveys will help us to plan where utility diversions will be required as we prepare to construct the railway in Birmingham.

Temporary traffic lights

To be able to carry out these inspections safely and effectively, we will need to put in place temporary traffic lights along sections of Aston Church Road. The lights will be operational from 9.30am to 3.30pm. Access to properties and businesses will be maintained at all times.

HS2 during the COVID-19 pandemic

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with guidance. 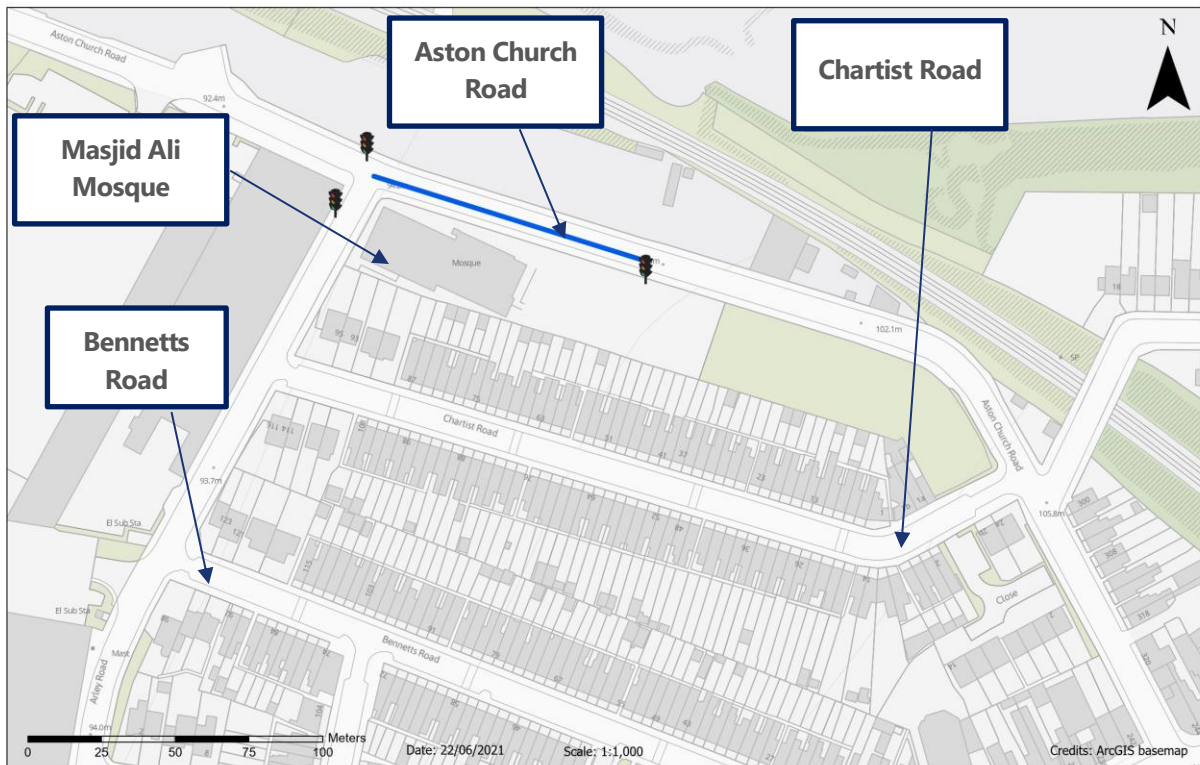
