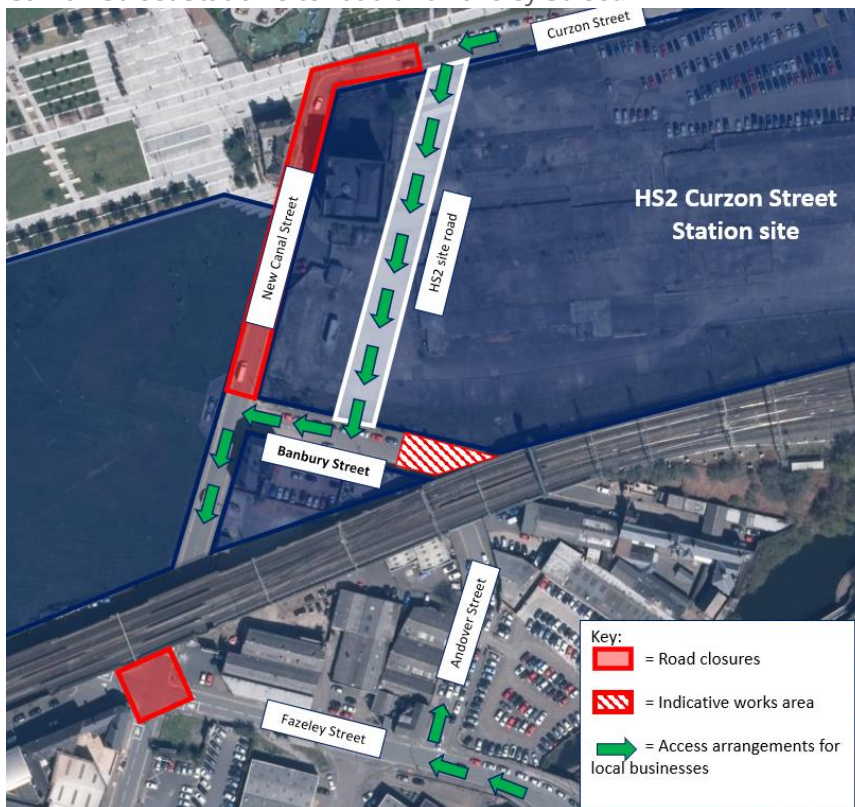
Notice of utility works on Banbury Street

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by a joint venture between Laing O'Rourke and Murphy & Sons known as LM.

Utility works on Banbury Street

Over the coming months, we'll continue to work on roads in central Birmingham and carry out a programme of utility diversions as we prepare for the construction of HS2's Curzon Street Station and the railway. From Thursday 8 July, there will be a partial road closure on Banbury Street. Access to local business will be provided via the HS2 Curzon Street Station site road and Fazeley Street.
