High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. You can sign up for regular updates in your local area at HS2inCamden.co.uk.

Weekend overnight works at track-level within Camden Cutting – September 2021 to March 2022

We have been carrying out protective works to strengthen the track-level railway bridge ahead of tunnelling later next year. We are installing ground anchors, steel work and supports beneath the bridge to strengthen and support the structure. We also continue to carry out surveys and monitoring of the various bridges and structures at track-level within the railway cutting.

For safety reasons, due to the location of the bridge beside, above and below the railway tracks, we can only carry out these works during a rail closure when trains on the nearby lines are not operating. We will continue to work overnight during weekends from September to March, and during the Christmas rail closure from 25 to 27 December, to complete work on the bridge. Works are not expected to be noisy.

Ground monitoring borehole on Park Village East – 20 to 24 September

We will install a borehole within the carriageway on Park Village East opposite Mornington Street bridge, to monitor ground movement in this area.

From 20 to 24 September, we will dig a trial hole within the carriageway to check for underground structures, before drilling a borehole and installing monitoring equipment. There may be periods of increased noise from concrete breaking as we dig the trial hole. We will use acoustic blankets where possible to limit noise and dust.

We will require footway closures and parking bay suspensions in front of 26 and 28 Park Village East (see map on next page). Access to properties will be maintained.

New site access staircase installed on Park Village East north

We will install a staircase, from 20 to 24 September, from street to track-level at the northern end of Park Village East to provide a safe and direct access for workers. The staircase will be positioned within the footway and planter on Park Village East, and extend over the brick parapet wall down to the track-level worksite. The location of the staircase will move over time, to make way for the works below.

We will also install a small 24/7 security cabin and hoarding at street-level around the staircase, for safety and security. The staircase and security cabin will eventually become part of the lorry lay-by, which we currently plan to install in early 2022. We will keep you updated with details about the lay-by.

The staircase needs to be positioned directly above the worksite, on the Park Village East side of the tracks. There is no safe alternative location for this access. We are aware of how close our works are to local residents and we will take measures to ensure we respect residents' privacy at all times and keep noise to a minimum.

During this time, we will require a lane and footway closure and parking bay suspensions opposite 8 & 10 Park Village East to install the staircase and hoarding. We will also need to clear some of the shrubs from the planter, to make way for the staircase.

Ongoing monitoring in and around the Euston Approaches

In September 2020, we installed prisms and reflectors on buildings and structures around the Euston Approaches, and installed ground studs on local footways. These instruments allow us to carry out surveys to monitor ground movement in the area around our worksite to make sure movement is within safe limits.

Our team visits these locations each week to carry out surveys, collect data and maintain the instruments. We will continue to carry out these surveys until the project is complete. We may visit certain locations more frequently when we are carrying out major works nearby.

The equipment we use records measurements and numbers. Please be reassured the equipment does not take images so your privacy is protected.

If you have any questions about surveys, monitoring or ground movement please email HS2 Helpdesk and we will get back to you in due course. Our surveyors will also be able to provide the HS2 Helpdesk contact details to anyone with questions about their work.
