

Notice of temporary footpath closure

High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance.

Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. You can sign up for regular updates in your local area at www.hs2inbucksandbox.co.uk

What will we be doing

Ahead of the main construction works in the former Aylesbury Golf Club site we will be continuing vegetation clearance around a number of the public right of ways.

For the safety of the pedestrian and personnel involved with the works, we will need to close the public rights of way whilst work is under way. We will need to close the footpaths each day between from 8:30am to 4:30pm. The footpaths will remain open outside of these hours.

Depending upon progress we will, where possible, provide a safe walking route along the footpath during this period of works. access to the public right of way will remain restricted during the two phases of works until work is complete. Signage will be erected advising of diversion routes.

How will this affect you?

We will be working hard to ensure any impacts to pedestrians are kept to a minimum. You may notice a little extra traffic immediately around the areas with workers and delivery vehicles activity. There may be some noise from the machinery, which will be restricted to running between the hours of 8am and 6pm Monday to Friday.
