# Install of ground monitoring equipment on local footways

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. ## Monitoring studs install on footways surrounding Euston Approaches worksite – 15 July to 13 August

We need to install ground studs within the footway on streets surrounding the Euston Approaches worksite for ground monitoring and surveys.

We will carry out this work in phases, starting on Hampstead Road on 15 July, before moving on to Park Village East, Parkway, Delancey Street and Mornington Terrace.

We will install small ground studs within the footway every 5 to 10m, using hand-held tools. For safety, we will carry out these works within a small barrier, moving the barrier along the footway as the works progress. We do not need to close the footway to carry out these works.

We will revisit these locations once a week to carry out surveys and repair and replace these studs until our work in the Euston Approaches is complete.
