

# Notice of 4 Way traffic lights Truggist Lane, Berkswell

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## The work we will be doing

BBV will be carrying out trial hole excavations in the existing verge of Truggist Lane near to Berkswell railway station bridge up to the junction of Baulk Lane. This is to identify existing utility services, construct protection slabs over existing utility services and construct a plant crossing for site traffic to cross Truggist Lane. To ensure the safety of our workforce BBV will work behind a lane closure which will be controlled by 4 way traffic lights replacing the permanent lights which will be powered off during this period. The temporary lights will be vehicular activated to minimise waiting time during off peak traffic flows.

## When these works will take place

Works are scheduled between the 12 July and 30 July. The 4 way traffic lights will be in place 24/7 during this period. Our working hours will be 8:00am to 5:00pm (subject to weather conditions).

### What to expect

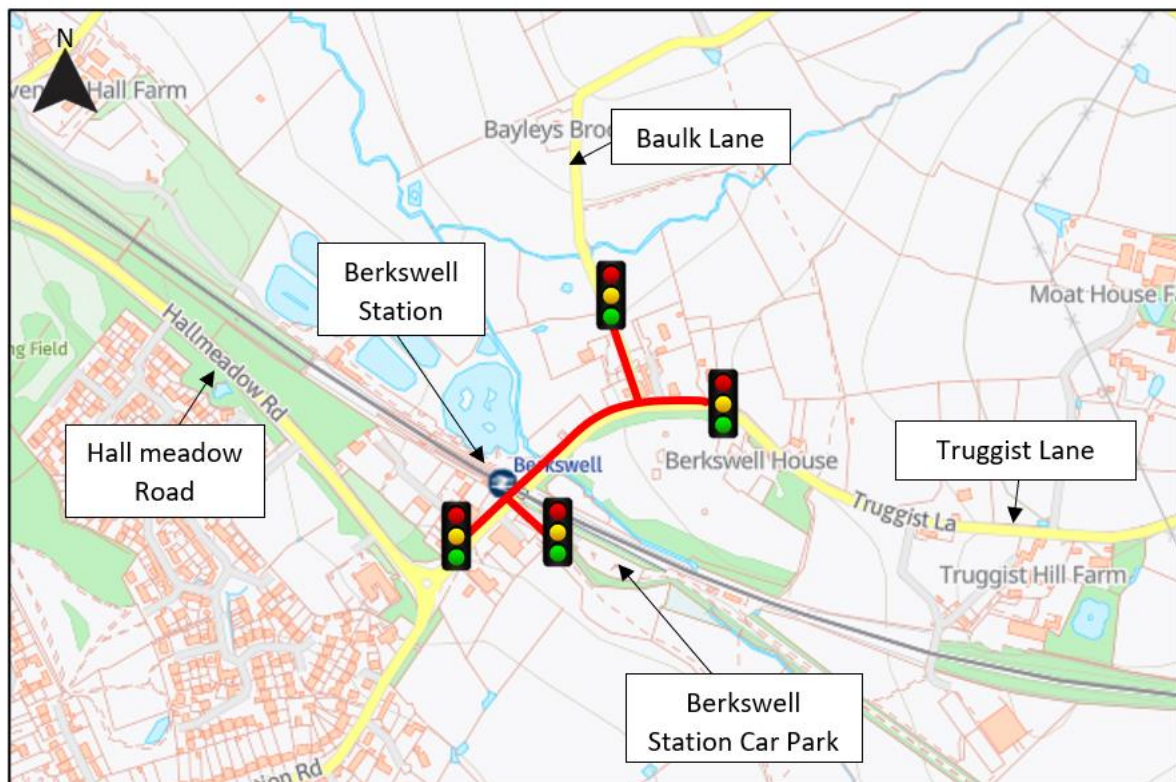
- 4 Way Vehicular Activated traffic lights.
