



Update: notice of ground investigation survey work

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty and its appointed subcontractors are working on behalf of HS2 Ltd to carry out the next round of ground investigation work on Phase 2a of HS2.

What the works involve

We're carrying out ground investigation works to help us better understand the ground conditions along the route. This will help to inform the detailed design of the railway. The ground investigation techniques that we will use on this project will primarily include the drilling of boreholes, trial pits and cone penetration tests.

In June 2021, we provided advance notice giving details of ground investigations taking place at Whitmore Wood. We needed to carry out further environmental work before we could start the work. As a result, we were unable to start this work when we anticipated. We will now start in September.

We may be using some heavy goods vehicles as well as light goods vehicles, such as tractors and telehandlers, to carry out the work at this site.

Covid-19

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.
