Borehole install behind 119 and 121 Parkway

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. Please be assured only sites that can operate within the guidelines are operational. You can sign up for regular updates in your local area at HS2inCamden.co.uk.

Borehole install behind 119 -121 Parkway – 12 to 16 July

We will install a new borehole in the car park area behind 119 -121 Parkway (in front of the gates to 117 Parkway), to replace the existing borehole. We will use this borehole to monitor the level of ground water in this area, helping us to plan and monitor the impact of our works.

We will close the car park area behind 119 -121 Parkway from 12 to 16 July to carry out these works. Parking in this area will be temporarily suspended. We apologise for inconvenience caused by these works.

We will use the smallest, least intrusive equipment possible. We will set up a small work site in the car park, surrounded by fencing and acoustic blankets. We will check for any existing utilities, before excavating and drilling the borehole. We will then cover the hole and reinstate the surface. We will place a small permanent access cover on the borehole, from which we will take regular readings as we have done with the existing one.

On 27 May HS2 has sent a Schedule 2 notice advising of these works and will send a further formal notification with additional details 7 days prior to the commencement of works.
