



# Network Rail closure - additional work update

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

## New site access points off Old Oak Common Lane

From 28 June, during the Network Rail road closure we will be constructing access points to our sites on Wormwood Scrubs. The new access points will all be located on Old Oak Common Lane. We will lower sections of the footpath and install concrete slabs to protect the services in the area. The new access points will allow construction vehicles to access and exit the site compounds on Wormwood Scrubs.

The works will involve a range of machinery including an excavator, vacuum excavator, generator/compressor, trucks for waste material haulage, dumper truck, and concrete trucks. For safety, the works areas will be segregated using mesh fencing.

Traffic Marshalls will be present on both sides of the road closure to help divert pedestrians and manage vehicle movements. We will monitor to ensure that noise does not exceed current permitted levels. In the event of a rise in noise levels, acoustic barriers will be used to reduce the noise.

Construction of new access points from 28 June to 11 July. From 8am to 6pm Monday to Friday and 8am to 1pm on Saturdays. No works will take place on Sundays.

Traffic management will be in place on Old Oak Common Lane.

Construction of new access points from Old Oak Common Lane into to Wormwood Scrubs.

We will use best practicable means to minimise any impact on our site neighbours.
