High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

Weekend air conditioning unit testing

As part of the works to set up our new site welfare cabins, we will be carrying out tests on the air conditioning units. These tests are required to ensure that the modules are in good working order prior to staff moving into the new welfare.

We will be carrying out the air conditioning tests on Saturday 24 and Sunday 25 July 2021. The tests need to be completed outside of our core working hours as an exclusion zone is required around the welfare cabins for safety reasons. We cannot do the tests during our normal core working hours as our site entrance would not be accessible.

During these works you may notice a small group of operatives on site. Most of the work will take place inside the welfare cabins and any noise will be minimal.

Dates mentioned in this notification may change due to unforeseen circumstances. We will continue to provide updates about our works at **HS2inKilburn-Northolt.co.uk**

You may notice some noise, but it will be minimal

Use handheld equipment to carry out tests on the air conditioning units

Advise operatives to be mindful of our neighbours during the works
