Bridge surveys in August 2021

We wrote to you in July about bridge surveys on Horsenden Lane South. Due to unforeseen circumstances, the surveys will now take place overnight on 18 and 19 August. Our surveying team will be visiting the railway bridge on Horsenden Lane South near Selbourne Gardens. The surveys will help to inform our design decisions.

We will take pictures and investigate the condition of the bridges using a mobile tower and ladders. The surveys should not cause any disruption.

Due to the location of the surveys, a lane closure with temporary traffic lights and bus stop suspension will be in place overnight to ensure the surveys can be carried out safely.
