High Speed Two (HS2) is the new high speed railway for Britain.

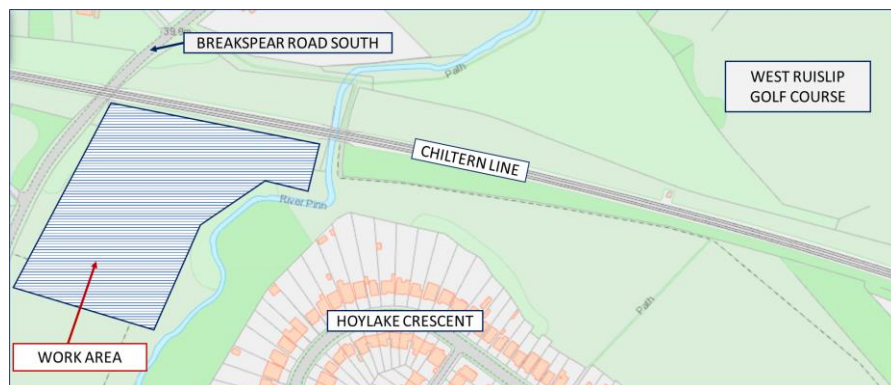
We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. What we are doing

From 26 May 2021, we will be carrying out enabling works in the area shown in the below map.

These works will help us to prepare the area for the temporary footpath diversion and the pedestrian bridge over the River Pinn. We will remove brambles and create a ditch to protect the area from potential flooding.
