High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

What we are doing

Over the coming months we will be carrying out enabling works in the area, shown on the map overleaf. These works will allow us to prepare the area which is required for the temporary storage and treatment of the soil that will be removed from the tunnels, before they are placed in their final location.

Our initial works will include:

- Setting up security fencing and hoarding
- Delivery of equipment for the removal of topsoil
- Vegetation clearance, including brambles and hedgerows
- Preparation works to secure and divert a section of the U49 footpath around the works area

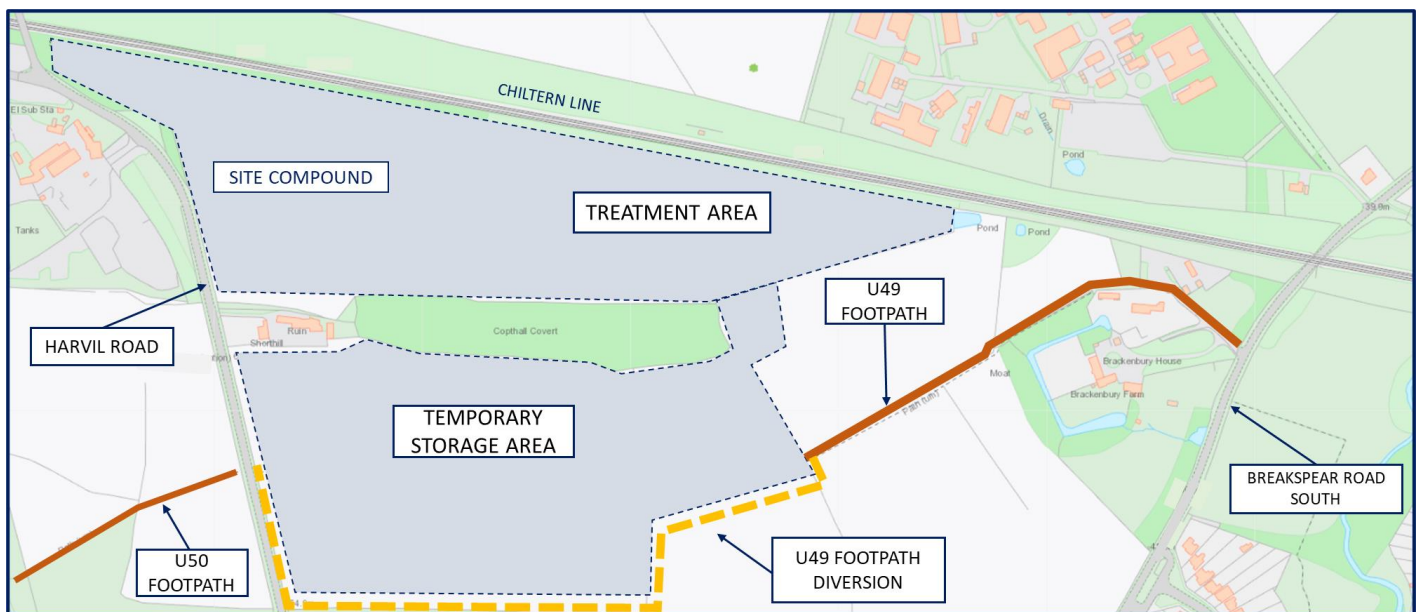
