Update: Notice of utility investigations on West End Road

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19.

What we are doing

We wrote to you recently to advise you that we would be carrying out ground investigation works from 10 to 20 August 2021. However, we need to reschedule these activities which will now take place from 16 to 28 August.

We will be carrying out ground investigation works along West End Road at the railway bridge, in the area shown on the map overleaf. This will help to inform our design decisions in the area.

These works will involve the use of scanning equipment to identify utilities in the area. We will be excavating trial holes to take measurements and ground samples.

How the surveys might affect you

For safety reasons, a lane closure will be in place and the footpath will be diverted for the duration of these activities.

There will be no disruption to your utility services.

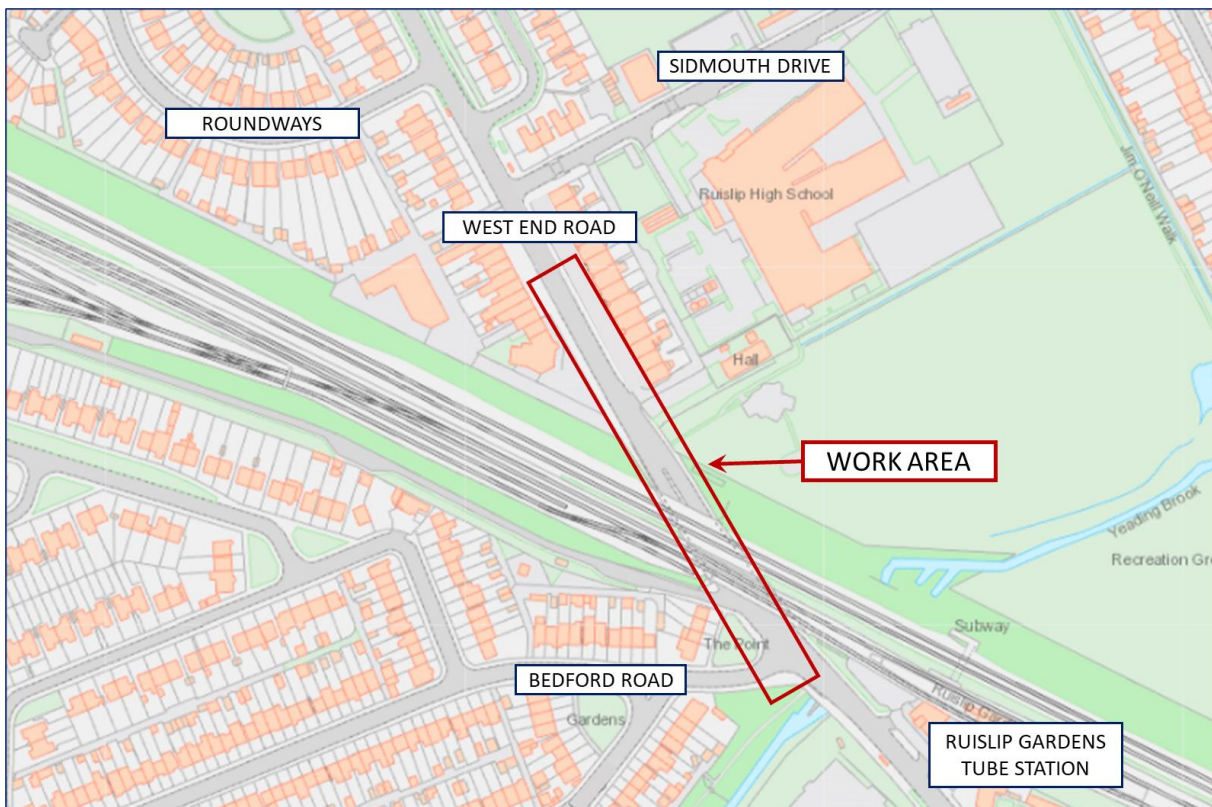
