









# Weekend works at our site on Harvil Road

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

## What we are doing

On the weekend of 24 and 25 July 2021, we will be carrying out utility installation works. We will be removing the road surface and excavating a trench to install cables and water pipes.

We will carry out the main cut into the concrete within normal working hours on Friday 23 July 8am to 6pm to minimise noise on the weekend. On Saturday 24 July and Sunday 25 July we will be working extended hours until 5pm. Once connected the trench will be backfilled and the work area reinstated, these activities should not cause any disruption.

These works will be confined to our site compound area, within the bell mouth where vehicles access the site from Harvil Road.

Your utility services will not be affected.
