Update: Notice of out of hours delivery at the Mandeville Road vent shaft site

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. You can sign up for regular updates in your local area at hs2inkilburnandnortholt.co.uk.

What we are doing

We notified you in June about some expected out of hours deliveries at our Mandeville Road site. This has been rescheduled to facilitate the installation of the site offices.

From 9 to 26 August 2021, we will be taking delivery of cranes and sheet piles at the Mandeville Road vent shaft site, in the area shown on the map overleaf. There will be two deliveries per evening outside of core working hours, between 8pm and 9pm. For safety reasons, we will temporarily stop traffic flow outside of our site to allow the lorries to reverse into site. Each delivery should take approximately fifteen minutes.

How the work might affect you

The traffic will be held by traffic marshals for 15 minutes to allow the lorries to reverse into site. Residents will hear lorries reversing up the access road and some flashing lights may be seen. A crane will unload the lorries the following morning to avoid unnecessary noise out of hours.

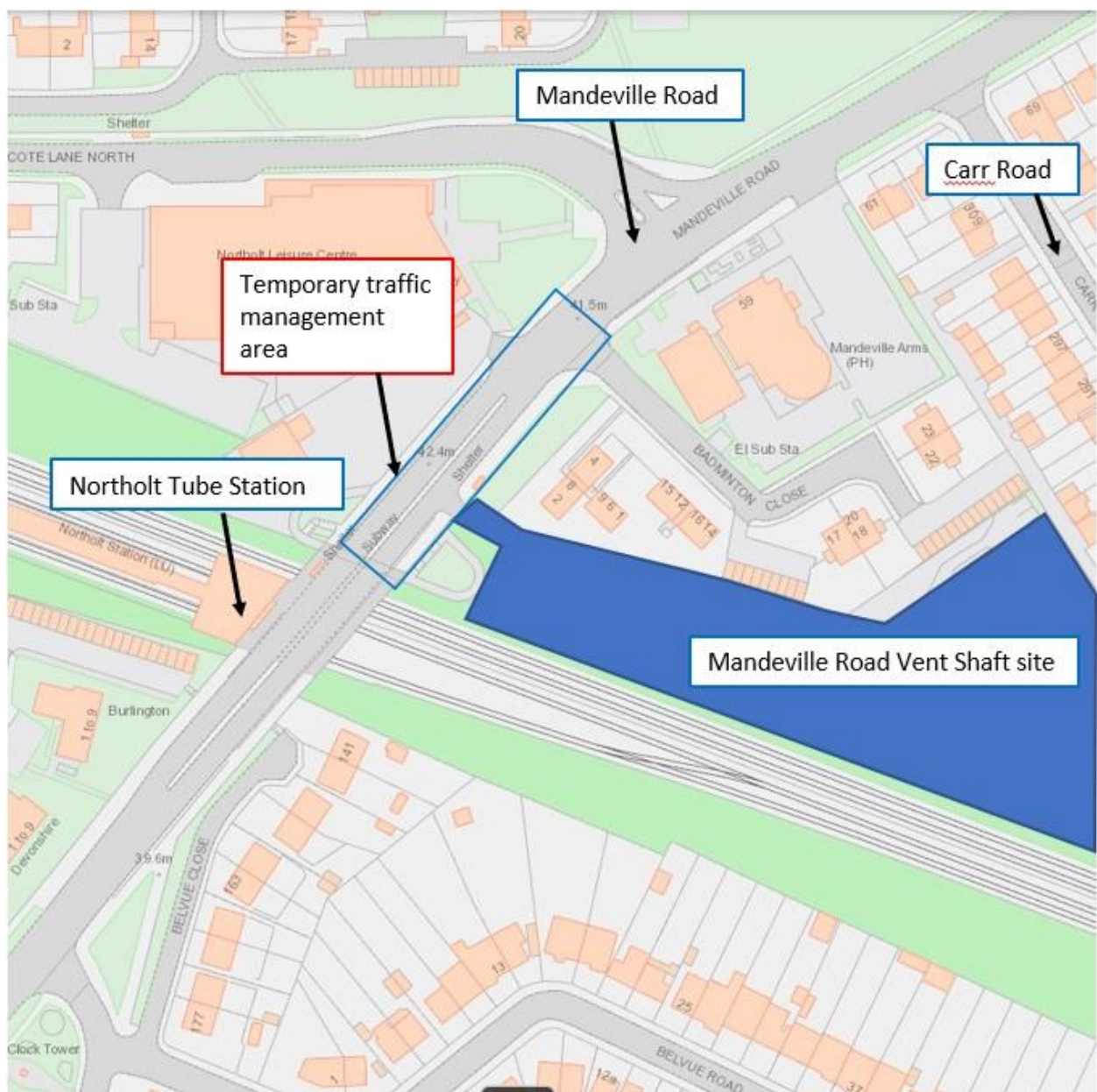
What we will do
