

Weekday road closure at Breakspear Road South

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

What we are doing

From 27 July 2021, for 3 nights a road closure will be in place to complete the installation of crash barriers near the entrance to our site on Breakspear Road South.

We will also conduct CCTV surveys by lowering a small robot with cameras into the sewer system. A water bowser will be on standby to jet wash away any blockages should it be needed.

How this work might affect you

A diversion will be in place via Swakeleys Road B467/ High Road B466/ Ickenham Road/ High Street/ Bury Street A4180/ Breakspear Road.

The closure and diversion are shown on the map overleaf.

The road closure will be in place from **9pm to 4am 27 July to 29 July**

We may be on site for an hour before the start and/or end of the closure

Breakspear Road South will be closed between the hours shown above

Ensure lights face work areas only

Ensure that the diversion route is clearly marked

Access will be maintained for residences north and south of the road closure
