High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be completing

In June 2021, we sent out a notification to outline that BBV would be completing the site access construction for our compound on the B4118 Birmingham Road. To continue these works we will now be completing some road surfacing on Monday 2 August 2021.

In order to carry out our works safely we will implement a temporary two-way traffic light system. Our temporary traffic lights will be in place from 9:30am – 3:30pm.

HS2 during the COVID-19 pandemic

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. - Our workforce to be on site 1 hour before and 1 hour after, to set up and take down equipment

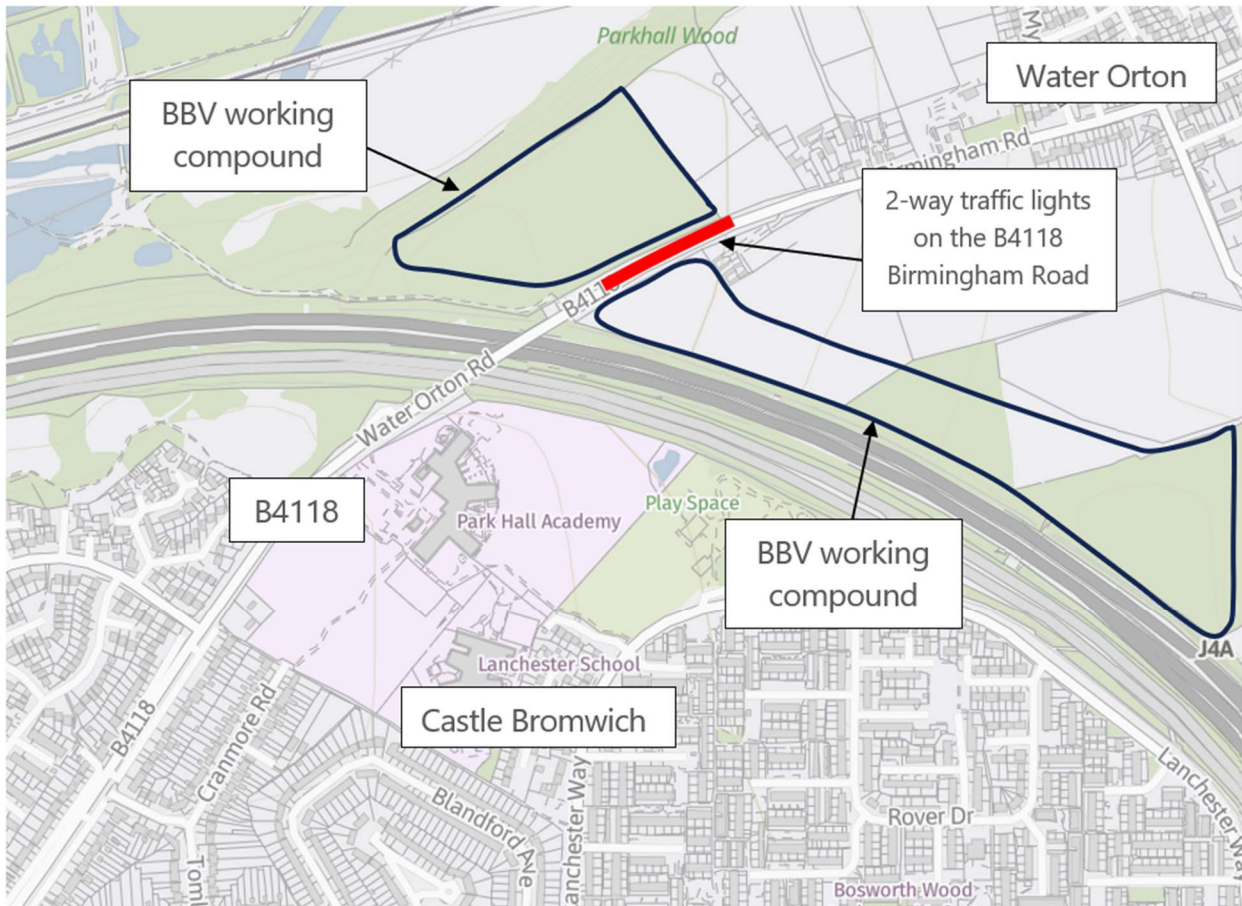
