



# Notice of temporary closure of Bangley Lane

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## The work we will be doing

We will be carrying out drainage surveys and utility surveys along Bangley Lane. To complete these surveys a team of engineers will visit the location and record what is present in the area and also carry out trial trenching, which will involve digging into the ground to establish what is underneath the surface. This will provide us with information on the location of drainage and underground utilities, which we need to assess as we develop our construction plans. For the work to be completed in a safe environment, we will close Bangley Lane (Access to properties will be maintained).

## When these works will take place

These works will take place between 2 August and 3 August from 9.30 am to 3.30 pm. We will close Bangley Lane to complete these works (see map on page 2). We will use an excavator vehicle and a small number of 4x4 vehicles, to install the traffic management and complete the works.

## HS2 during the Coronavirus pandemic

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with coronavirus.

The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance.

The health and safety of our workforce and the communities we affect is our key priority.

These surveys will take place between 2 August and 3 August.

Our working hours will be 9.30 am to 3.30 pm (Mon-Tues).

Our workforce may be on site one hour before and after to set up and take down our work equipment.

Bangley Lane will be closed while we complete these works.

We will install signage on the roadside.

Some low level noise will be generated from the work we are completing.

Inform you in advance of any changes to the date(s) shown.

Keep all sites safe and secure.

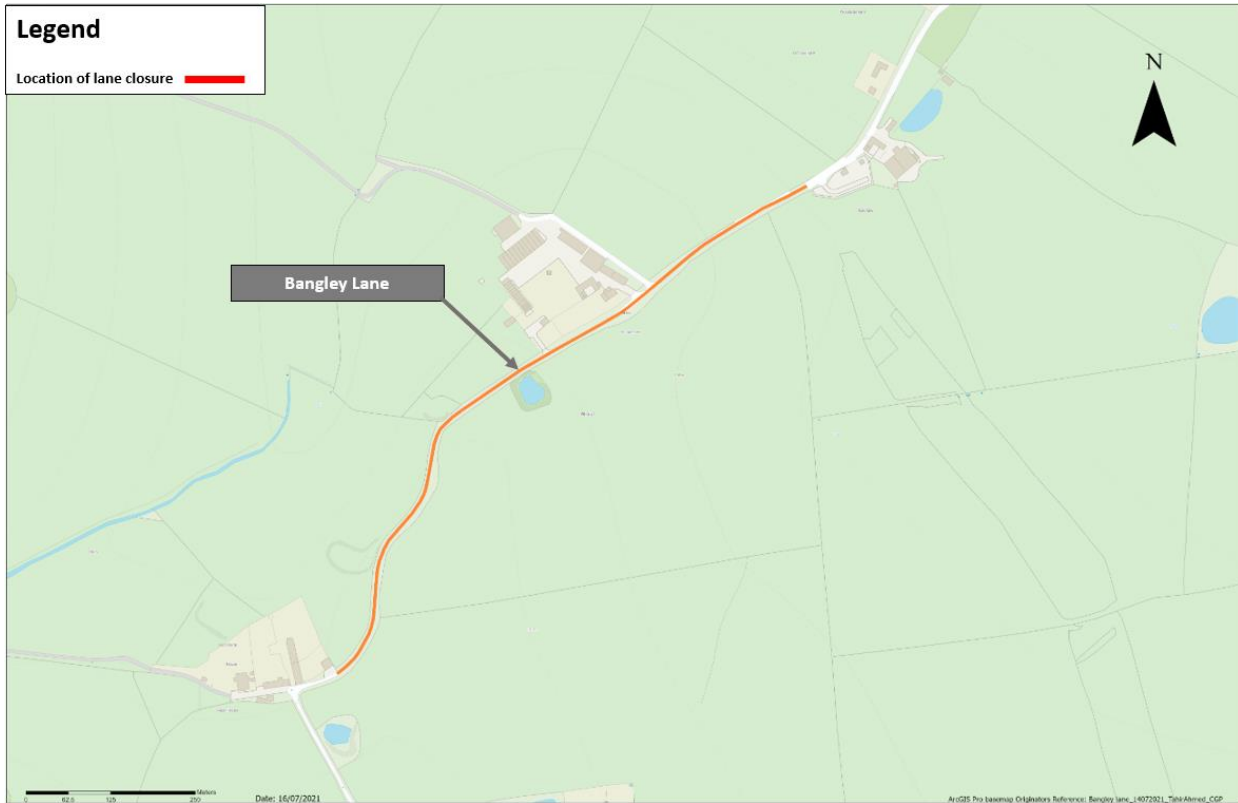
