



Update: Notice of ground investigation survey work

High Speed Two (HS2) is the new high speed railway for Britain. Working on behalf of HS2 Ltd, Balfour Beatty is carrying out surveys and investigating ground conditions along the Phase 2a route.

What we are doing

We're carrying out ground investigation work to help us better understand the ground conditions along the route. This will help to inform the detailed design of the railway. To do this, we will use techniques including the drilling of boreholes and trial pits. We are carrying out this work on land near the existing railway track off Waybutt Lane.

We expected to complete this work in October but due to unforeseen circumstances, we need to remain in this location a little bit longer than anticipated.

To carry out the work, we will use some heavy goods vehicles as well as light goods vehicles, such as tractors and telehandlers.

How we will reduce disruption

We will keep construction traffic to a minimum, wherever possible. To reduce impact on your journeys, we will avoid travelling at peak times during the day. We will also keep our sites secure at all times.

Covid-19

We are working in line with Government and Public Health England (PHE) advice on working safely during the pandemic. For all events and engagement, we will carry out a risk assessment and put in place control measures to manage the risk of Covid-19 to the public and our staff. Duration of works

- Works started 29 July 2021. New expected end date: 3 December 2021
- Our working hours will be 8am to 6pm, Monday to Friday

What to expect

- Slightly more traffic than usual on Chorlton Lane and Waybutt Lane for the duration of works
- Possible visual and sound impacts to your property. We will install sound barriers around the perimeter of the drilling equipment to reduce noise levels.

What we will do

- Carry out the work in compliance with the Code of Construction Practice
- Inform you in advance of any changes to the dates and working times
- Keep all sites safe and secure
