High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

### Upcoming utility surveys

We will be carrying out utility trial hole surveys in locations along sections of Crawford Street, Cranby Street and Adderley Road on Thursday 19 August and Friday 20 August, dates are subject to the progress of the surveys programme.

To complete the utility trial hole inspections, we will use a vacuum excavator, which uses compressed air to loosen or agitate the ground. The loosened material is then removed using the vacuum on the machine creating a hole. At times we will also use hand digging tools to excavate the trial holes. Once the surveys are carried out, we will backfill and reinstate all the trial holes.

These surveys will help us to plan where utility diversions will be required as we prepare to construct the railway in Birmingham.

### Overnight road closure and temporary traffic lights

To be able to carry out these inspections safely and effectively, we will need to put in place an overnight road closure with a diversion route along a section of Crawford Street on 19 August.

We will also need to put in place lane closures with temporary traffic lights on sections of Cranby Street and Adderley Road on 20 August.

The closures will be operational from 9:00pm to 5:00am. Access to properties and businesses will be maintained at all times.

Cranby Street and Adderley Road traffic lights 20 August (1 night)

Ensure that our work areas are safe and secure.

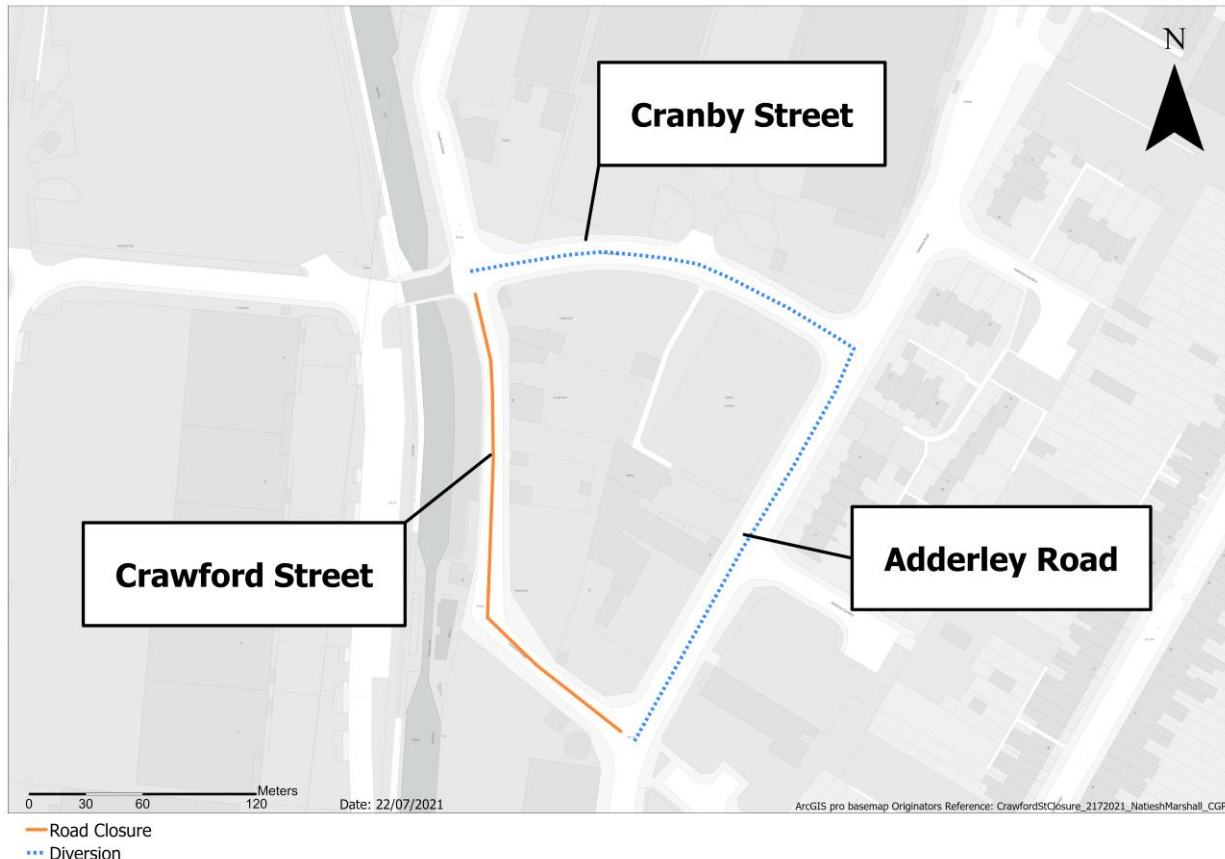

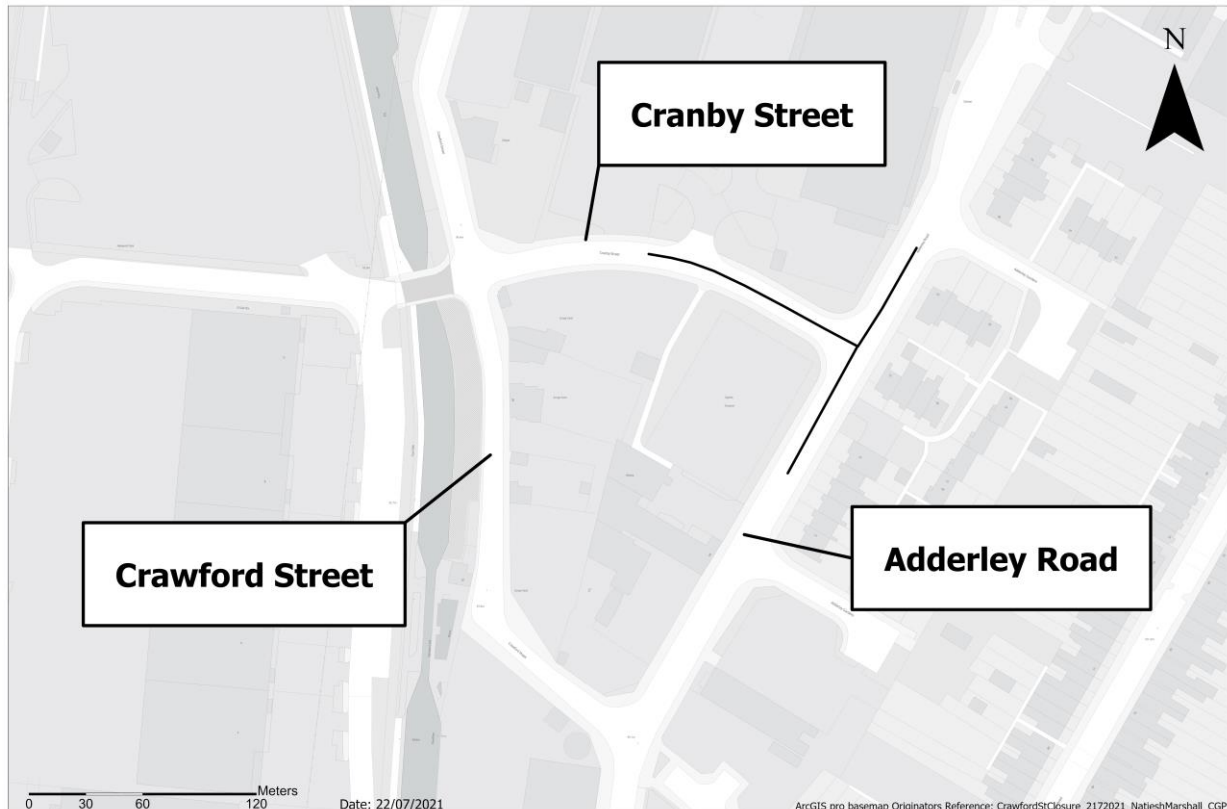
