High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The design areas that are being changed

As part of our works in the Interchange Station Area BBV will be constructing the Pool Wood Embankment to carry the HS2 trainline and an underbridge for the Coleshill Heath Road. The following design updates have been made to these works and this will have an impact on Heath Park.

- The Pool Wood Embankment will now be higher to create more clearance, meaning there will be no need to lower Coleshill Heath Road.
- There will be a retaining wall used on the western side of the Pool Wood Embankment between Coleshill Heath Road Underbridge and the M6 Motorway South Viaduct. This will replace an earth embankment slope.

Why these changes are being made

- The increase to the height of the Pool Wood Embankment will simplify the construction process and reduce the impact on local traffic during construction.
- The use of a retaining wall instead of an embankment will save space and mean less land is taken from Heath Park permanently.

The construction work impacts

Originally it had been envisaged that our construction compound would cover a larger area of Heath Park, which would have resulted in the temporary loss of both football pitches. However, working in collaboration with Solihull Council this was reviewed, and an agreement has been reached to reduce the area occupied, minimising impact on the park and enabling one of the two football pitches to remain for community use. The compound will be in use for approximately three and a half years. Once construction is complete the area will be returned to public use. Unfortunately, the permanent loss of part of the park for the Pool Wood Embankment means that it will not be possible to reinstate the second football pitch. However, BBV is keen to leave a positive legacy for the community and is looking into different options to contribute to a project to develop facilities at Heath Park. Solihull Council are working with the local community to identify some of these options for us to consider.


