



## Notice of Balfour Beatty VINCI works on Network Rail asset

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

### Network Rail works

In early 2021, Balfour Beatty VINCI sent out a notification to outline works we were completing on the Network Rail track to install lineside protection. This lineside protection enables us to create a safe environment for our construction workers and users of the existing rail network, whilst we construct HS2.

The second phase of this work is now due to commence, starting Saturday 14 August. We will then continue working for three weekends up until 5 September.

To complete this work, we will enter the working area through the existing Network Rail access point close to Lea Marston. We will also utilise an access gate at Newlands Farm, however this will only be used by passenger vehicles.

### What work will be taking place

We will complete surveys, install monitoring equipment, and complete the installation of the lineside protection.

### Working hours

In order to reduce the impact on normal rail operations, lineside working will be completed throughout the day and overnight on weekends.

- August 2021 to September 2021
- Four weekends of work

- Works will include BBV constructing lineside protection on Network Rail asset
- Use of Newlands Farm gate – for passenger vehicles only
- Use of existing Network Rail access point for plant and machinery


