



# Notice of drainage inspections Aston Church Road

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

## Upcoming drainage inspections

Our drainage inspections which were due to take place from Monday 26 July to Wednesday 28 July will now take place from Wednesday 28 July to Friday 30 July.

Drainage inspections are non-intrusive surveys, which means that the inspection will only consider that which is visible and accessible. An operative will lift the manhole cover, use a sewer camera to examine the underground pipes and replace the cover.

These surveys will help us to plan where utility diversions will be required as we prepare to construct the railway in Birmingham. To be able to carry out these inspections safely and effectively, we will need to put in place temporary traffic lights in locations along Aston Church Road. The locations of the traffic lights will change as we carry out drainage inspections along different sections of the road. Access to residential properties and other buildings will be maintained at all times.

## HS2 during the COVID-19 pandemic

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with the guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

Ensure that there is clear signage in place.

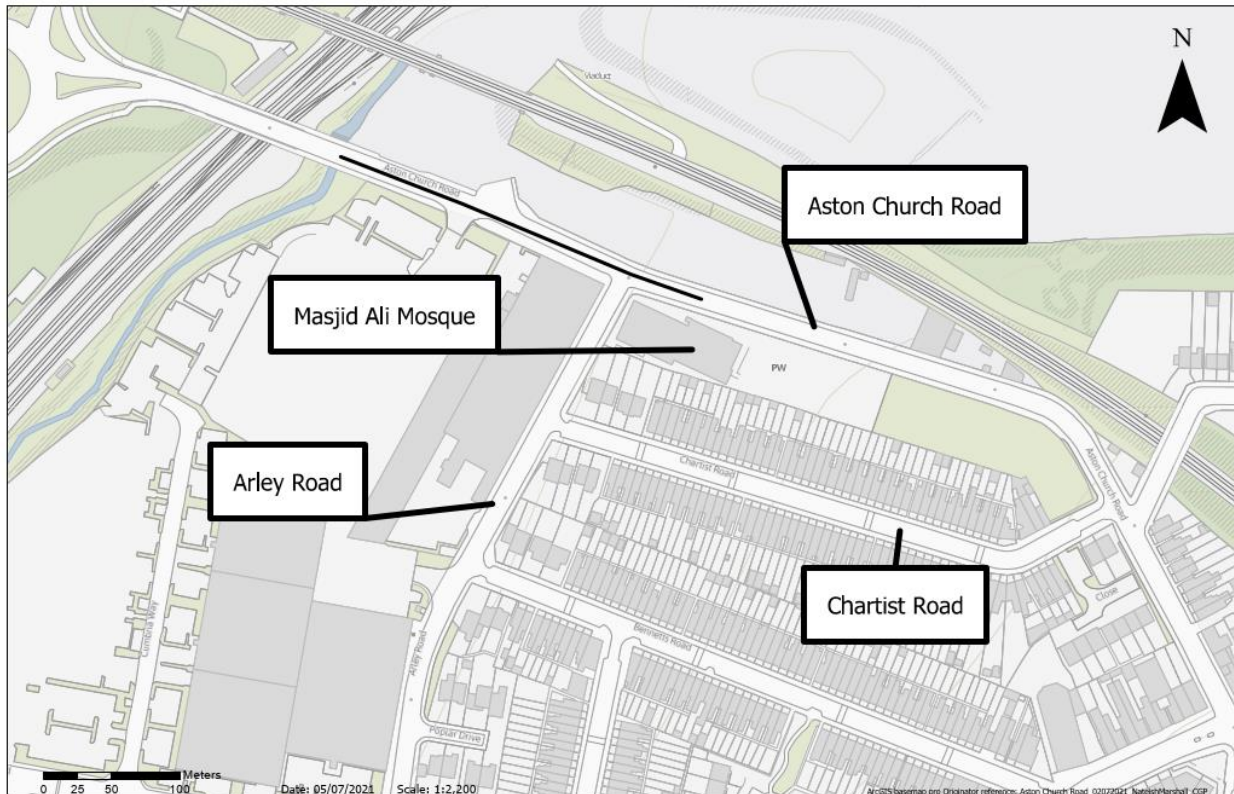
