# Notice of equipment trial at West Ruislip site

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

### What we are doing

We will be carrying out a 5-day trial of a machine that breaks down concrete into smaller reusable parts.

If this trial is successful, it will mean that the number of lorry movements required to transport concrete to and from site will be reduced and will remove a significant number of lorries from local roads.

Monitor sound levels throughout the trial

Use acoustic noise reducing blankets to minimise noise

Use water spray cannons around the machinery to reduce dust
