High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

#### The work will we be doing

In early July 2021, we sent out a notification to outline that BBV would have some temporary traffic management in place on the B4114 Birmingham Road, to safely remove some of our machinery from site. Unfortunately, due to unforeseen circumstances, some of the traffic management was not able to take place.

We have now replanned our traffic management to happen on Friday 30 July. Our temporary traffic lights will be in place from 9:30am - 3:30pm, although we will continue working in the compound area from 8am - 6pm.
