



## Notice of overnight rail works – near Millburn Grange Farm, Kenilworth

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

### The work we will be doing

BBV will be carrying out track monitoring and other survey works including cable route surveys of the existing Network Rail equipment on the Leamington Spa to Coventry rail line. This is to allow for monitoring of rail equipment before and during construction works for HS2 and to identify existing cables within the Network Rail boundaries. Later in the year minor activities will take place to enable cable diversions away from Network Rail tracks. Please see map overleaf for works location.

### When these works will take place

The survey and monitoring works are scheduled for the following Saturday nights: **17 July, 14 August, 11 September, 9 October, 16 October, 23 October, 30 October, 6 November and 4 December 2021. These works will finish 8:30am Sunday mornings.** These works are non-intrusive with only very low levels of noise being generated. These works are subject to weather conditions.

The Leamington Spa to Coventry line will be closed between midnight and 8.30am. The workforce will gain access to the existing track through the dedicated access near Millburn Grange Farm. We will keep you updated through [www.hs2inwarwickshire.co.uk](http://www.hs2inwarwickshire.co.uk).

- Low levels of noise from the work we are completing.

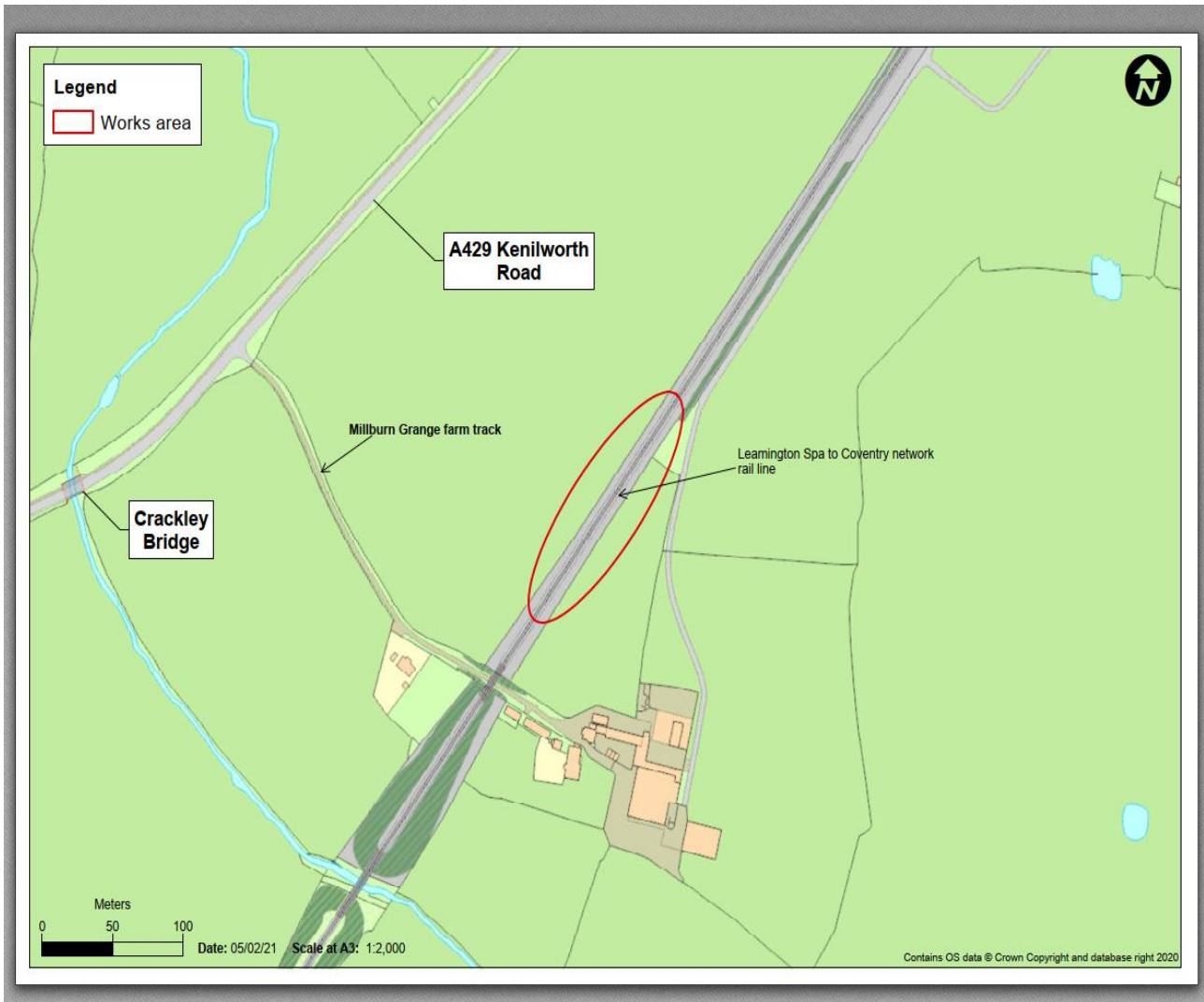
