Transport information

We will be undertaking a program of deliveries of various materials to the Cubbington and Coventry Road compounds.

This program of deliveries will commence from 5 August 2021 to February 2022.

A maximum of 60 HGVs will travel between Cubbington and Coventry Road compounds each day.

This is compared to original 90 HGVs per day as mentioned in the original environmental statement.

Timings

Delivery will take place between Monday and Fridays from 08.00am – 6.00pm and on Saturdays from 08.00am to 1.00pm.

To Minimize the impact on local traffic deliveries will be regulated throughout the working day and made during off peak hours whenever possible.


