High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

We will be completing two aspects of work

- Installation of a plant crossing across the Attleboro Lane
- Utility disconnections on the houses due to be demolished

To complete the works safely, we will implement a temporary road closure on Attleboro Lane. The road closure will be marshalled, so access for residents and pedestrians will still be maintained. The temporary closure will be in place from Wednesday 4 August for 3 weeks.


