Monthly ground water surveys on Park Village **East**

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. Please be assured only sites that can operate within the guidelines are operational. You can sign up for regular updates in your local area at HS2inCamden.co.uk.

Ground water surveys within the Park Village East carriageway from June

We need to take samples of the ground water below Park Village East to monitor and assess the impact of our works as we progress. From June, until the end of the project, we will take monthly water samples from the borehole located within the carriageway at the northern end of Park Village East. This borehole is located beside the parking bays outside 10 and 12 Park Village East.

On the first Wednesday of each month, we will narrow the road at the northern end of Park Village East using road cones to create a safe working zone while a small team of two carries out the survey. We do not need to suspend the parking bays to carry out these surveys, and access to parking will be maintained at all times. The surveys will take about an hour to complete, after which we will remove the traffic management.
