High Speed Two (HS2) is the new high speed railway for Britain.

Update: sheet piling removal trial in Camden Cutting worksite – 12 to 18 August

We previously informed you we will be carrying out a trial to remove sheet piles from 9 to 13 August within our worksite, between Granby Terrace and Mornington Street bridge.

Due to delays onsite, we will now carry out this trial from 12 to 18 August, during weekday core working hours only.

We want to trial our method, which may produce some vibration, ahead of the removal works planned for September. These works are needed to remove a section of sheet piles that we were using to support a large excavation. We plan to pull the sheets out of the ground using a non-vibratory piling rig, but if the sheets are stuck, we may need to use a vibratory piling rig to loosen the sheets before pulling them out.

We will use this trial to help identify any further measures to reduce the impact of these planned works. We will monitor these works closely to ensure we remain within the noise and vibration limits agreed with the local council.

UKPN cable install on Mornington Street bridge – 23 August to 13 September

UKPN is currently installing electricity cables within the footway and carriageway on local streets surrounding the Euston Approaches, to provide power to our worksites.

From 23 August to 13 September, UKPN will install cables within the south-side footway and westbound carriageway on Mornington Street bridge.

The bridge will remain open. Works will be carried out in phases, starting from Park Village East across the bridge to Mornington Terrace. Each phase will require footway and lane closures on Park Village East, Mornington Street bridge and Mornington Terrace, with temporary traffic lights in place.

We will divert pedestrians to the north-side footway, and we will maintain safe crossing on both sides of the bridge.

Overnight CCTV utility survey on Parkway – 23 to 25 August

We previously informed you we would carry out a CCTV utility survey of the sewer system beneath Parkway overnight from 30 to 31 July.

Unfortunately, we were unable to complete the survey due to blockages.

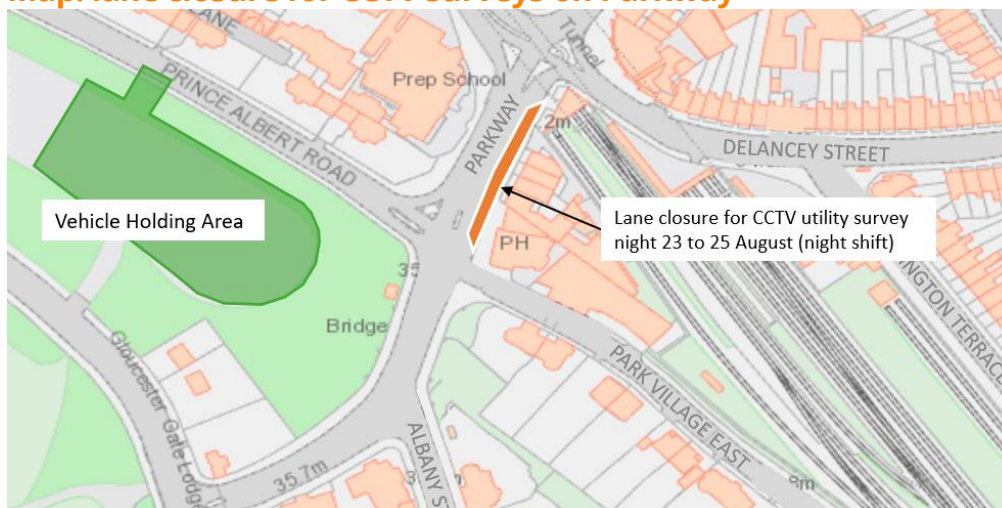
We will now return on 23 and 24 August to complete the survey. We will carry out the works over two-night shifts, working from 8pm to 5am the following day. We will access the sewer via existing manholes within the road and use a camera to assess the condition of the sewer.

We are carrying out these works overnight to limit impact on local traffic. A section of the lane in front of the properties at 117 to 129 Parkway will be closed to create a safe working area. Access to these properties will be maintained at all times. These works will not be noisy and will not cause disruption to the sewer system.

We will use this survey to inform the final design of the Parkway utility diversion works. We will begin works to strengthen and divert the utilities beneath Parkway in February 2022, before we begin tunnelling, to prevent potential damage to the utilities from tunnel-related ground changes.

We also need to carry out CCTV surveys on Albert Street, Mornington Terrace, Clarkson Row, Park Village East, Stanhope Street and Augustus Street in September. We will provide you further information closer to the time.
