



## Installation of temporary traffic lights on the B4453 Rugby Road, Cubbington

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

### The work we will be doing

We will be installing temporary traffic lights in order to carry out trial hole and ground surveys in the existing verge of B4453 Rugby Road, Cubbington. This is to identify existing utility services, construct protection slabs over existing utility services and carry out ground condition surveys.

### When these works will take place

We will be installing off-peak temporary traffic lights on the B4453 Rugby Road, Cubbington between 23 August and 27 August. This will take place between the hours of 9:30am and 3:30pm. Please note that these works are subject to weather conditions (please see map overleaf).

### HS2 during the Coronavirus pandemic

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with coronavirus.

The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance.

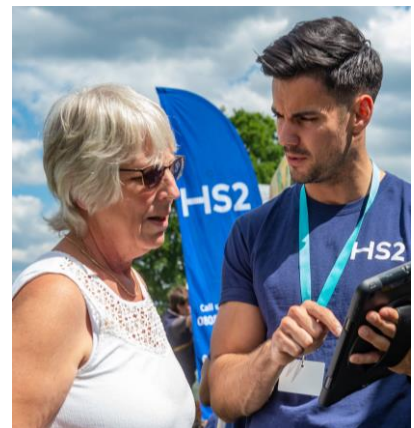
## About our Community and Business Funds
