High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

Topographic surveys

We will be carrying out overnight topographic surveys in locations along Duddeston Mill Road, Inkerman Street, Devon Street and Network Park from Friday 6 August to Tuesday 17 August (excluding weekends). Dates are subject to the progress of the surveys programme.

To complete the surveys a team of engineers will visit the locations and record what is present in the area using a digital measure or camera. This will include recording the location and sizes of features such as hedges, grid covers, kerbs, road layout and road markings.

These surveys will help us to finalise the design of the new railway and where possible allow us to reinstate features after construction.

Overnight lane and road closures

To be able to carry out these inspections safely and effectively, we will need to put in place overnight lane closures with temporary traffic lights along sections of Duddeston Mill Road, Inkerman Street and Devon Street.

We will also need to put in place a controlled closure along a section of road leading into Network Park. The closure will be manned to allow access and exit to Network Park.

The closures will be operational from 9.00pm to 5.00am. Access to properties and businesses will be maintained at all times.

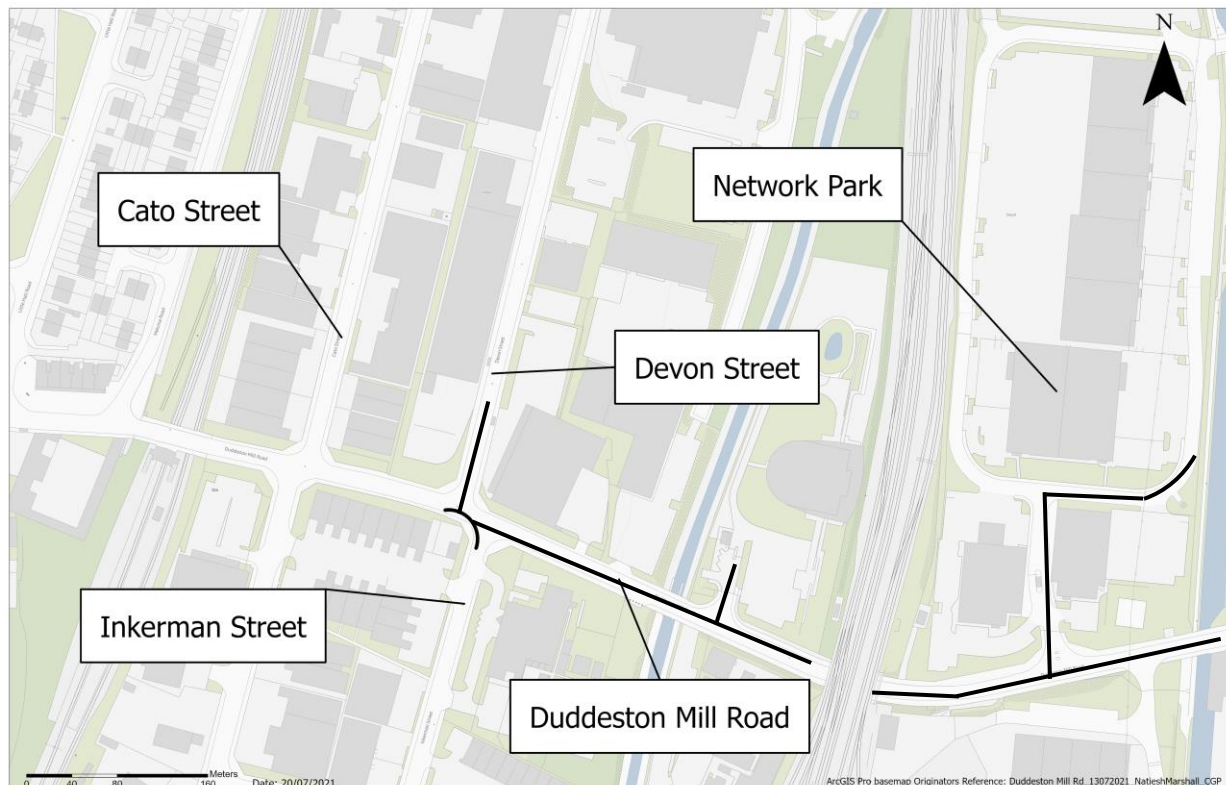
