# Update: Notice of surveyor visits in Ruislip

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19.

### Surveyor visits

We wrote to you in early July to advise you that our surveying team will be visiting railway bridges on Long Drive to carry out surveys. We will require two additional nights to complete these works which will take place on 16 and 17 August 2021.

We will take pictures and investigate the condition of the bridges using a mobile tower and ladders. The surveys will help to inform our design decisions in the area and should not cause any disruption.

Due to the location of the surveys, temporary traffic management will be in place to ensure the activity can be carried out safely.
