High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19.

What we are doing

On 7 and 8 August 2021, we will be carrying out repair works to the existing access from the bell mouth junction off Ickenham High Road at the West Ruislip site entrance.

If any asphalt needs to be cut, this will be carried out on the Friday within normal working hours in order to minimise noise at the weekend.

Once the repairs have been undertaken, new asphalt will be laid, compacted and road markings will be reinstated.

Road planers, breakers, excavators and JCB vehicles will be used to remove concrete and then asphalt delivery lorries and rollers to reinstate and compact the new road surface
