# Notice of utility investigations on Long Drive

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19.

#### What we are doing

From 13 to 18 September 2021, we will be carrying out ground investigation works along Long Drive at the railway bridge, in the area shown on the map overleaf. This will help to inform our design decisions in the area.

These works will involve the use of scanning equipment to identify utilities in the area. We will be excavating trial holes to take measurements and ground samples.

#### How the surveys might affect you

Temporary traffic management will be in place to ensure the investigation can be carried out safely. The footpath will be closed for the duration of these activities and a diversion will be in place.

There will be no disruption to your utility services.
